<u>TAX PAYER IMPACT STATEMENT</u> – House Bill 1522, passed by the 89th Texas Legislature, amends section 551.043 of the Texas Government Code to require that the notice of a meeting required to be posted under section 551.043(a) of the Texas Open Meetings Act, at which a governmental body will discuss or adopt a budget for the governmental body, must include a taxpayer impact statement showing, for the median-valued homestead property, a comparison of the property tax bill in dollars pertaining to the property for the current fiscal year to an estimate of the property tax bill in dollars for the same property for the upcoming fiscal year.

<u>PLEDGE OF ALLEGIANCE</u> – Councilman Martin led the Pledge of Allegiance to the United States Flag and the Texas Flag.

<u>COMMENTS FROM THE AUDIENCE</u> – No comments received.

<u>CONSENT CALENDAR</u> – Motion was made by Councilman Ginn and seconded by Councilman Haight to approve the consent calendar as follows:

- 1. Approval of the workshop and regular meeting minutes for October 21, 2025.
- 2. Acceptance of the Deer Park Community Development Corporation quarterly report for the period of July 1, 2025 September 30, 2025.

3. CONSIDERATION OF AND ACTION ON AMENDMENT NUMBER TEN (10) TO THE AGREEMENT WITH THE CITY OF DEER PARK FOR FCPEMSD PERSONNEL, VEHICLES, FACILITIES, EQUIPMENT, INVESTMENTS AND GRANT ADMINSTRATION. – Motion was made by Councilwoman Garrison and seconded by Councilman Martin to authorize entering into the amendment number ten (10) to the agreement between the City of Deer Park and the Fire Control District for FCPEMSD personnel, vehicles, facilities, equipment, investments and grant administration.

Motion carried 7 to 0.

4. CONSIDERATION OF AND ACTION ON AMENDMENT NUMBER TEN (10) TO THE AGREEMENT WITH THE DEER PARK CRIME PREVENTION DISTRICT (CCPD) FOR CCPD PERSONNEL, VEHICLES, FACILITIES, EQUIPMENT, INVESTMENTS AND GRANT ADMINSTRATION. – Motion was made by Councilman Ginn and seconded by Councilman League to authorize entering into the amendment number ten (10) to the agreement between the City of Deer Park and the Crime District for CCPD personnel, vehicles, facilities, equipment, investments and grant administration.

Motion carried 7 to 0.

5. CONSIDERATION OF AND ACTION ON A RESOLUTION ADOPTING THE CITY OF DEER PARK PERSONALLY IDENTIFIABLE INFORMATION POLICY. – After a proposed resolution was read by caption, motion was made by Councilman Martin and seconded by Councilwoman Ford to adopt Resolution No. 25-18, captioned as follows:

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF DEER PARK ADOPTING THE PERSONALLY IDENTIFIABLE INFORMATION POLICY OF THE CITY OF DEER PARK, TEXAS.

Motion carried 7 to 0.

6. CONSIDERATION OF AND ACTION ON A RESOLUTION ADOPTING THE CITY OF DEER PARK PURCHASING POLICY. – After a proposed resolution was read by caption, motion was made by Councilman Ginn and seconded by Councilman Martin to adopt Resolution No. 25-19, captioned as follows:

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF DEER PARK, TEXAS AMENDING SECTION 4, PURCHASING PROCEDURES, AND SECTION 5, PRICE QUOTATION AND PURCHASE AWARDS, OF THE PURCHASING POLICY TO INCLUDE PROCEDURES FOR REQUISITIONS AND PURCHASE ORDERS; APPROVAL OF PURCHASES; AND PURCHASES NOT SUBJECT TO COMPETITIVE BIDDING.

7. CONSIDERATION OF AND ACTION ON AN ORDINANCE AMENDING CHAPTER
10, ALCOHOLIC BEVERAGES, SEC 10-1 AND SEC 10-2 AS IT RELATES TO SB
1008. – After a proposed ordinance was read by caption, motion was made by Councilman
Martin and seconded by Councilwoman Ford to adopt Ordinance No. 4659, captioned as
follows:

AN ORDINANCE AMENDING CHAPTER 10, ALCOHOLIC BEVERAGES, SEC 10-1 AND SEC 10-2 IN THEIR ENTIRETY, OF THE CODE OF ORDINANCES OF THE CITY OF DEER PARK, TEXAS TO COMPLY WITH THE NEW SENATE BILL 1008 REGARDING CITY ISSUED ALCOHOL PERMITS, AND PROVIDING FOR AN EFFECTIVE DATE AND PROVIDING FOR SEVERABILITY.

CONSIDERATION OF AND ACTION ON AUTHORIZATION TO PURCHASE OF TRAFFIC SIGNAL DETECTION CAMERAS FOR THREE INTERSECTIONS VIA HGAC CONTRACT #PE-05-21. – Motion was made by Councilman Ginn and seconded by Councilman League to approve the authorization to purchase traffic signal detection cameras for three intersections via HGAC Contract #PE-05-21.

Motion carried 7 to 0.

9. CONSIDERATION OF AND ACTION ON AUTHORIZATION TO PURCHASE TWO
(2) 2025 CHEVROLET SILVERADO 1500 DOT VEHICLES, FROM PARKWAY
CHEVROLET AND THE PARKWAY BUYBOARD. PURCHASE THE OUTFITTING
OF THE DOT TRUCKS FROM PARKWAY CHEVROLET. - Motion was made by
Councilman League and seconded by Councilwoman Garrison to authorize the purchase
of two Chevrolet Silverado 1500 DOT vehicles from Parkway Chevrolet and the Parkway
BuyBoard as well as approval of purchase of outfitting said vehicles from Parkway
Chevrolet.
