

BID BOND

KNOW ALL MEN BY THESE PRESENTS, that we the undersigned,

Turner Paving & Construction, Inc. as PRINCIPAL, and

Harco National Insurance Company, as SURETY are

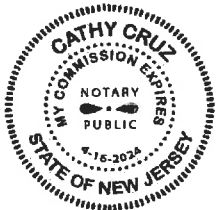
