
1. MEETING CALLED TO ORDER – Chairman Wendeburg called the meeting to order at 7:30 p.m.

3. APPROVAL OF MINUTES - Motion was made by Commissioner Tippit and seconded by Commissioner Garrett to approve the minutes as follows:

CONSIDERATION OF AND ACTION ON THE RESULTS FROM OF THE PUBLIC HEARING ON THE REQUEST FROM DEER PARK CITY COUNCIL TO AMEND ZONING ORDINANCE 10.03 TO ALLOW A HELISTOP IN A HIGHWAY DISTRICT ZONING DISTRICT – Motion was made by Commissioner Balusek and seconded by Commissioner Garrett to make a recommendation to City Council to approve the request from the City Council on amending the Zoning Ordinance 10.03 to allow a helistop in the Highway Zoning District. Motion carried 5 to 0.

CONSIDERATION OF AND ACTION ON THE REQUEST FROM GEORGE GENNEDY AND OAKLAKE COMMUNITY HOUSING TO REZONE 301 WEST SAN AUGUSTINE STREET FROM SINGLE FAMILY 2 (SF-2) TO MULTI-FAMILY 2 (MF-2) FOR THE PURPOSE OF CONSTRUCTING AND OPERATING A SENIORS ONLY MULTI-FAMILY PROPERTY – Motion was made by Commissioner Cox and seconded by Commissioner Tippit to schedule a public hearing on December 04, 2017 at 7:00 p.m. on the request from George Gennedy and Oaklake Community Housing to rezone 301 West San Augustine Street. Motion carried 5 to 0.


6. ADJOURN – Chairman Wendeburg adjourned the meeting at 7:37 p.m.
