CALL TO ORDER – Mayor Mouton called the meeting to order at 7:30 p.m.

<u>INVOCATION</u> – The invocation was given by Councilwoman Ford.

<u>PLEDGE OF ALLEGIANCE</u> – Councilwoman Garrison led the Pledge of Allegiance to the United States Flag and the Texas Flag.

<u>COMMENTS FROM THE AUDIENCE</u> – Jennifer Suarez, 2202 Kristina Way, expressed her concerns of the search that was conducted by the Deer Park Police for a suspect within her neighborhood. Ms. Suarez emphasized her displeasure with the way the situation was handled.

1. PUBLIC HEARING ON THE PROPOSED AD VALOREM TAX RATE FOR TAX YEAR 2025 – The public hearing was opened at 7:39 p.m. City Secretary Angela Smith read the Notice of Public Hearing. (Exhibit A)

CONSIDERATION OF AND ACTION ON AUTHORIZATION OF PARKING AND ISSUANCE OF TEMPORARY OCCUPANCY PERMIT REQUEST FROM PEMEX DEER PARK FOR THEIR FALL 2025 "BIG BLOCK" TURNAROUND – Motion was made by Councilman League and seconded by Councilman Martin on authorization of parking and issuance of temporary occupancy permit request from Pemex Deer Park for their Fall 2025 "Big Block" turnaround.

Motion carried 6 to 0.

5. <u>CONSIDERATION OF AND ACTION ON AMENDING THE FINANCIAL MANAGEMENT POLICY</u> – Motion was made by Councilman Ginn and seconded by Councilman League on amending the Financial Management Policy.

Motion carried 6 to 0.

6. <u>CONSIDERATION OF AND ACTION ON THE ADOPTION OF THE FIVE-YEAR CAPITAL IMPROVEMENTS PLAN FOR YEARS 2026-2030</u> — Motion was made by Councilwoman Garrison and seconded by Councilman Ginn on the adoption of the Five-Year Capital Improvements Plan for years 2026-2030.

Motion carried 6 to 0.

7. CONSIDERATION OF AND ACTION ON A RESOLUTION TO TRANSFER \$6,000,000.00 FROM THE FISCAL YEAR 2024-2025 UNASSIGNED FUND BALANCE FROM THE GENERAL FUND TO THE CAPITAL IMPROVEMENTS FUND – After a proposed resolution was read by caption, motion was made by Councilman Ginn and seconded by Councilwoman Ford to adopt Resolution No. 25-14, captioned as follows:

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF DEER PARK, TEXAS TRANSFERRING \$6,000,000.00 OF UNASSIGNED FUND BALANCE IN THE GENERAL FUND TO THE CAPITAL IMPROVEMENTS FUND FOR CURRENT AND FUTURE PROJECTS.

Motion carried 6 to 0.

8. CONSIDERATION OF AND ACTION ON A RESOLUTION TO TRANSFER \$2,000,000 FROM THE FISCAL YEAR 2024-2025 UNASSIGNED FUND BALANCE OF THE GENERAL FUND TO THE ASSET REPLACEMENT FUND — After a proposed resolution was read by caption, motion was made by Councilman Martin and seconded by Councilman League to adopt Resolution No. 25-15, captioned as follows:

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF DEER PARK, TEXAS TRANSFERRING \$2,000,000.00 OF UNASSIGNED FUND BALANCE IN THE GENERAL FUND TO THE ASSET REPLACEMENT FUND FOR CURRENT AND FUTURE PROJECTS.

9. CONSIDERATION OF AND ACTION ON A RESOLUTION MAINTAINING THE CITY OF DEER PARK'S CONTRIBUTION RATE TO THE TEXAS MUNICIPAL RETIREMENT SYSTEM (TMRS) AT THE OBLIGATED 15.52% FOR 2026 AND NOT PREFUNDING THE CITY'S UNFUNDED ACTUARIAL ACCRUED LIABILITY – After a proposed resolution was read by caption, motion was made by Councilman Ginn and seconded by Councilwoman Ford to adopt Resolution No. 25-16, captioned as follows:

A RESOLUTION OF THE CITY OF DEER PARK CITY COUNCIL MAINTAINING THE CITY'S 2026 MUNICIPAL CONTRIBUTION RATE TO THE TEXAS MUNICIPAL RETIREMENT SYSTEM (TMRS) AT 15.52 PERCENT AND NOT PREFUND THE UNFUNDED ACTUARIAL ACCRUED LIABILITY (UAAL) IN YEAR 2026.

Motion carried 6 to 0.

10. CONSIDERATION OF AND ACTION ON AN ORDINANCE ADOPTING THE FY 2025-2026 BUDGET FOR THE CITY OF DEER PARK – After a proposed ordinance was read by caption, motion was made by Councilman Martin and seconded by Councilman Ginn to adopt Ordinance No. 4650, captioned as follows:

AN ORDINANCE ADOPTING THE 2025-2026 BUDGET FOR THE CITY OF DEER PARK, TEXAS AND APPROPRIATING THE SEVERAL SUMS SET UP THEREIN TO THE OBJECTS AND PURPOSES THEREIN NAMED.

CONSIDERATION OF AND ACTION ON AN ORDINANCE LEVYING AD VALOREM TAXES FOR TAX YEAR 2025 – After a proposed ordinance was read by caption, a motion to move that the property tax rate be increased by the adoption of a tax rate of \$0.720000, which is effectively a 5.02 percent increase in the tax rate was made by Councilman Ginn and seconded by Councilman League to adopt Ordinance No. 4651, captioned as follows:

AN ORDINANCE OF THE CITY OF DEER PARK, TEXAS LEVYING AD VALOREM TAXES FOR 2025 AT \$0.720000 PER ONE HUNDRED DOLLARS ASSESSED VALUATION OF ALL TAXABLE PROPERTY WITHIN THE CORPORATE LIMITS TO PROVIDE REVENUES FOR CURRENT EXPENSES AND INTEREST AND SINKING FUND REQUIREMENTS; PROVIDING DUE AND DELINQUENT DATES; PENALTIES AND INTEREST; PROVIDING A HOMESTEAD EXEMPTION; REPEALING ALL OTHER ORDINANCES IN CONFLICT; AND PROVIDING AN EFFECTIVE DATE.

AN ORDINANCE PROVIDING FOR A RECLASSIFICATION SCALE AND PAY RANGE CHART FOR EMPLOYEES OF THE CITY OF DEER PARK; PROVIDING A PAY RANGE CHART FOR UNCLASSIFIED SERVICE EMPLOYEES.

CONSIDERATION OF AND ACTION ON AN ORDINANCE MOVING THE TIME OF THE OCTOBER 7, 2025, REGULAR CITY COUNCIL MEETING FROM 7:30 PM TO OCTOBER 7, 2025 AT 5:30 PM – After a proposed ordinance was read by caption, motion was made by Councilwoman Ford and seconded by Councilman Ginn to adopt Ordinance No. 4653, captioned as follows:
