CONSIDERATION OF AND ACTION ON ENTERING INTO AN INTERLOCAL AGREEMENT WITH TEXAS DIVISION OF EMERGENCY MANAGEMENT (TDEM) FOR MEDICAL SERVICES DIRECTOR SERVICES – Motion was made by Councilwoman Ford and seconded by Councilman League to authorize entering into an interlocal agreement with Texas Division of Emergency Management (TDEM) for Medical Services Director services.
