Subject: Asset Seizure and Forfeiture Review (2024/2025)

During the 2024/2025 fiscal year, the Department made seven cash seizures. The summary of each case is listed below.

- Deer Park Case number 25-01278 was filed with the Harris County District Attorney's Office on 04/14/2025 in the amount of \$1,365.00. A charge of Burglary of a Vehicle was filed against Lester Earl Robinson.
- Deer Park Case number 25-01557 was filed with the Harris County District Attorney's Office Asset Forfeiture Division. A total of \$35.00 was seized as winnings during an undercover gambling operation. No charges have been filed.
- Deer Park Case number 25-01558 was filed with the Harris County District Attorney's Office Asset Forfeiture Division. A total of \$9,972 was seized during an undercover gambling operation. No charges have been filed.
- Deer Park Case number 25-01559 was filed with the Harris County District Attorney's Office Asset Forfeiture Division. A total of \$73.00 was seized as winnings during an undercover gambling operation. No charges have been filed.
- Deer Park Case number 25-01560 was filed with the Harris County District Attorney's Office Asset Forfeiture Division. A total of \$7,759.00 was seized during an undercover gambling operation. No charges have been filed.
- Deer Park Case number 25-01734 was filed with the Harris County District Attorney's Office Asset Forfeiture Division. A total of \$500.50 was seized during an undercover gambling operation. No charges have been filed.
- Deer Park Case number 25-02185 was filed with the Harris County District Attorney's Office Asset Forfeiture Division. A total of \$2,326.00 was seized during the investigation. A charge of Possession of a Controlled Substance PG 1 4-200gm with intent to deliver and Unauthorized Use of a Motor Vehicle were filed against Matthew Estrada.

During the 2024/2025 fiscal year, the Department received thirteen deposits from cash seizures and one deposit from the sale of a previously seized vehicle.

- On 9/30/2025 the Deer Park Police Department received \$2,850.00 from the sale of a previously seized 2008 Ford Explorer Sport Trac.

During the 2024/2025 fiscal year, two individuals were arrested at the time of offense. After a review of the case reports, no behaviors or trends were observed that would indicate bias-based profiling occurred.
