#### CITY OF DEER PARK RESOLUTION NO. 24-\_\_\_\_

#### A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF DEER PARK, TEXAS, APPROVING THE ADOPTION OF ELECTION EQUIPMENT FOR THE CONDUCT OF ALL MUNICIPAL ELECTIONS.

- **WHEREAS,** the City of Deer Park, Texas, Article III, Sec. 3.05 of the City Charter states all city elections shall be governed by the laws of the State of Texas governing general and municipal elections; and
- **WHEREAS,** the City is required to conduct municipal elections in compliance with the Texas Election Code, ensuring the secure, efficient, and accessible execution of such elections; and
- **WHEREAS,** the City Council recognizes the need for accurate, reliable, and secure election equipment to uphold the integrity of the election process and maintain voter confidence; and
- WHEREAS, Pursuant to Texas Election Code Sec. 123.001, Adoption of Voting System Required, the authority designated by this section, by resolution, order, or other official action of the authority, must adopt the system for use in the elections. Election Code Sec. 123.006, Adoption of Voting System for Early Voting, a voting system may be adopted for use in early voting only, regular voting on election day only, or both; and
- WHEREAS, the City of Deer Park has reviewed available election equipment options and determined that the adoption of Verity Controller 2.7.2, Verity Scan 2.7.6, Verity Touch Writer Duo 2.7.2, and KNOWiNK electronic poll pads is in the best interest of the City to ensure secure and efficient election administration for use during early voting in person, early voting by mail, election day, and provisional ballots for all municipal elections; and
- WHEREAS, Hart InterCivic is selected as the provider of Verity Controller 2.7.2, Verity Scan 2.7.6, and Verity Touch Writer Duo 2.7.2, and such equipment has been certified for use by the Texas Secretary of State's Office and complies state standards for election technology, a copy of the City's confirmation and Hart InterCivic certification letters are enclosed hereto as Exhibit A; and
- WHEREAS, KNOWiNK has been selected as the provider for the electronic poll pads in place of paper poll books to check in voters and determine whether they have already received or voted a mail ballot and will allow the City to see voter turnout in near real-time. The Texas Secretary of State's Office has the authority to develop procedures and standards for the certification of electronic pollbook systems used in Texas elections and to assess vendors of electronic pollbook systems for compliance with those standards and with the requirements of the Texas Election Code. KNOWiNK has received certification for the use of their pollbook systems in Texas, the certification and recertification letters are enclosed hereto at Exhibit B; and
- **WHEREAS,** the City of Deer Park's adoption of the Verity Controller 2.7.2, Verity Scan 2.7.6, Verity Touch Writer Duo 2.7.2, and the KNOWiNK electronic poll pads will enhance voter accessibility, promote transparency, and streamline election processes.

### BE IT RESOLVED BY THE COUNCIL OF THE CITY OF DEER PARK, TEXAS,

- SECTION 1: That the City Council of the City of Deer Park hereby approves the adoption of the Verity Controller 2.7.2, Verity Scan 2.7.6, Verity Touch Writer Duo 2.7.2, and the KNOWiNK electronic poll pads for use in all municipal elections held by the City of Deer Park.
- SECTION 2: That the City was authorized to enter into any necessary contracts or agreements with Hart InterCivic for the acquisition, implementation, and maintenance of the Verity Controller 2.7.2, Verity Scan 2.7.6, and Verity Touch Writer Duo 2.7.2, in accordance with the City's procurement policies and procedures, enclosed hereto as Exhibit C.
- SECTION 3: That the City was authorized to enter into any necessary contracts or agreements with KNOWiNK for the acquisition, implementation, and maintenance of the electronic poll pads, in accordance with the City's procurement policies and procedures, enclosed hereto as Exhibit C.
- SECTION 4: That this Resolution shall take effect immediately upon its passage and adoption.
- SECTION 5: That any prior resolutions or portions thereof that are in conflict with this Resolution are hereby repealed to the extent of the conflict.

REPORT OF REVIEW OF HART INTERCIVIC VERITY VOTING 2.7 SYSTEM

Jane Nelson Secretary of State

### PRELIMINARY STATEMENT

On March 1-2, 2023, and July 6, 2023, Hart InterCivic Inc. ("Hart" or the "Vendor") presented the Verity Voting 2.7 system for examination and certification. The examination was conducted in Austin, Texas at the Office of the Texas Secretary of State (the "Office"). Pursuant to Sections 122.035(a) and (b) of the Texas Election Code, the Secretary of State appointed the following examiners:

- 1. Mr. Tom Watson, an expert in electronic data communication systems;
- 2. Mr. Brian Mechler, an expert in electronic data communication systems;
- 3. Mr. Brandon Hurley, an expert in election law and procedure; and
- 4. Mr. Charles Pinney, an expert in election law and procedure.

Pursuant to Section 122.035(a), the Texas Attorney General appointed the following examiners:

- 1. Mr. Robert Thomson, an expert in electronic data communication systems; and
- 2. Mr. Austin Kinghorn, an employee of the Texas Attorney General.

On March 1, 2023, Mr. Mechler, Mr. Pinney, and Mr. Thomson witnessed the extraction of the trusted build and the installation of the Verity 2.7 software and firmware that the Office received directly from the Independent Testing Authority. The examiners, assisted by Office staff, compared the generated hashes from each device to the trusted hashes that the U.S. Election Assistance Commission ("EAC") provided to the Office. The hash validation was successful. Mr. Pinney, assisted by Office staff, conducted the examination of the accessibility components of the Verity Touch Writer Duo, Verity Touch Writer Duo Standalone, and Verity Touch Writer with Access devices.

On March 2, 2023, the Vendor demonstrated the system and answered questions presented by the examiners. After the vendor presentation, the examiners conducted a test election and tested other components of the system. The results of the test election were accumulated and verified for accuracy by Office staff.

On July 6, 2023, the examiners examined the Verity Transmit and Verity Transmit Receiving Station components of the system. The examiners conducted a test election using those components to verify the accuracy and security of the transmission process. The results of the test election were accumulated and verified for accuracy by Office staff.

On August 3, 2023, pursuant to Section 122.0371 of the Texas Election Code, the Office held a public hearing for interested persons to express views for or against the certification of the Verity Voting 2.7 system.

## **BRIEF DESCRIPTION OF VERITY VOTING 2.7**

The Verity Voting 2.7 system is an updated version of the Verity Voting 2.5 system, which the Office certified in April 2021 for use in Texas elections.

Verity Voting 2.7 includes software enhancements to the existing election management system and updates to other previously certified hardware components, including the Verity Touch Writer Duo, Verity Touch Writer Duo Standalone, and Verity Touch Writer with Access ballot marking devices, the Verity Scan precinct scanner, and the Verity Central central scanner. Verity Voting 2.7 also includes an additional software component (Verity Transmit) and an additional hardware component (Verity Transmit Receiving Station).

Verity Voting 2.7 has been evaluated at an accredited independent voting system laboratory for conformance to the 2005 Voluntary Voting System Guidelines (VVSG). Verity Voting 2.7 was certified by the EAC on June 7, 2022.

### FINDINGS

The following are the findings, based on written evidence submitted by the Vendor in support of its application for certification, oral evidence presented at the examination, and the written reports of the voting system examiners (all of whom recommended certifying the Verity Voting 2.7 system for use in Texas elections, subject to the condition outlined below).

The Verity Voting 2.7 system, including its hardware and software components, meets the standards for certification as prescribed by Section 122.001 of the Texas Election Code. Specifically, the Verity Voting 2.7 system and its components, among other things:

- 1. Preserve the secrecy of the ballot;
- 2. Are suitable for the purpose for which they are intended;
- 3. Operate safely, efficiently, and accurately and comply with the voting system standards adopted by the Election Assistance Commission;
- 4. Are safe from fraudulent or unauthorized manipulation;
- 5. Permit voting on all offices and measures to be voted on at the election;
- 6. Prevent counting votes on offices and measures on which the voter is not entitled to vote;
- 7. Prevent counting votes by the same voter for more than one candidate for the same office or, in elections in which a voter is entitled to vote for more than one candidate for the same office, prevent counting votes for more than the number of candidates for whom the voter is entitled to vote;
- 8. Prevent counting a vote on the same office or measure more than once;
- 9. Permit write-in voting; and
- 10. Are capable of providing records from which the operation of the voting system may be audited.

## CONDITIONS

The Secretary of State imposes the following condition on the certification of the Verity Voting 2.7 system:

1. The Verity Transmit module must be used in accordance with the procedures prescribed by the Secretary of State under Section 127.1231(b) of the Texas Election Code for the

module to be considered within the scope of the certification of the Verity Voting 2.7 system.

### CONCLUSION

Consideration of and action on approval of contracts with Hart Intercivic and KNOWiNK, LLC and approval of the purchase of new Verity Duo election equipment from Hart Intercivic using BuyBoard Contract #710-23 and poll iPads from KNOWiNK,LLC.

### Summary:

Recent legislation was passed that requires entities to have a "auditable voting system" by 2026. Our current equipment was purchased in 2011. The system includes eSlates (actual voting machines) and Judge's Booth Controllers (JBC) and are considered Direct Recording Electronic voting machines (DRE). This type of machine does not provide an auditable voting system and Hart InterCivic recently informed us that they are no longer able to source parts for repairs or replacement of our type of machines.

In order to purchase the equipment now instead of waiting till 2026, a quote was obtained from Hart InterCivic for the purchase of Verity Scan 2.7.1, Verity Control 2.7.1 and Verity Touch Writer Duo 2.7.1 plus additional accessories and requirements. A BuyBoard contract was used with the quote from Hart InterCivic.

A Hybrid voting system (Verity) is one where the voter makes the selection on a digital terminal a.k.a. DRE machine - but unlike the traditional DRE, these terminals do not record the voter's selections. Instead, those choices are printed on a paper ballot for the voter to review and confirm. Once the voter is satisfied with the contents of the printed ballot, the ballot is inserted into a separate machine - an optical scanner - that counts the ballot and then deposits it in the ballot box.

The City Secretary's office will also be purchasing two iPads from KNOWiNK LLC in order to use those for voter check-in (\$680). The software for the iPads will be purchased through the same BuyBoard contract with Hart Intercivic.

Hart has already obtained the required Texas Secretary of State approval of the contract for the new election equipment per state law. Hart will also take our current election equipment and dispose of it correctly with the proper notice to the Texas Secretary of State's office (if needed).

Jim Fox, City Attorney reviewed the contracts and provided his approval and the vendor will be providing the HB 1295 form before the council meeting.

Fiscal/Budgetary Impact:

This is an approved budget item that will be paid from the Asset Replacement Fund Expenditure for the City Secretary's department in the amount of \$80,043.
