CALL TO ORDER – Mayor Mouton called the meeting to order at 7:30 p.m.

INVOCATION – The invocation was given by Councilwoman Ford.

<u>PLEDGE OF ALLEGIANCE</u> – Councilwoman Garrison led the Pledge of Allegiance to the United States Flag and the Texas Flag.

COMMENTS FROM THE AUDIENCE – No comments received.

<u>CONSENT CALENDAR</u> – Motion was made by Councilman Ginn and seconded by Councilman League to approve the consent calendar as follows:

- 1. Approval of workshop meeting minutes for August 06, 2024.
- 2. Approval of regular meeting minutes for August 06, 2024.
- 3. Authorization to seek bids for the sale of surplus water meters.
- 4. Acceptance of the Quarterly Investment Report for the quarter ended June 30, 2024.
- 5. Acceptance of the Quarterly Financial Report for the Fiscal Year 2023-2024 Third Quarter Ended June 30, 2024.

Motion carried 6 to 0.

6. CONSIDERATION OF AND ACTION ON AN AGREEMENT WITH GRANITE GOVERNMENT SOLUTIONS FOR PHONE LINES PREVIOUSLY PROVIDED BY AT&T COPPER SERVICE – Motion was made by Councilman Ginn and seconded by Councilwoman Ford on an agreement with Granite Government Solutions for phone lines previously provided by AT&T copper service.

Motion passed 6 to 0.

7. CONSIDERATION OF AND ACTION ON AUTHORIZING NOBLE TEXAS BUILDERS TO PERFORM THE REHABILITATION OF THE WATER PLANT LABORATORY USING BUYBOARD CONTRACT 728-24 – Motion was made by Councilman League and seconded by Councilman Martin on authorizing Noble Texas Builders to perform the rehabilitation of the Water Plant Laboratory using BuyBoard Contract 728-24.

Motion carried 6 to 0.

8. CONSIDERATION OF AND ACTION ON AUTHORIZATION TO AMEND THE INTERLOCAL AGREEMENT WITH HARRIS COUNTY TO ADD AN ADDITIONAL \$100,000 FROM THE CITY OF DEER PARK FOR A JOINT HIKE AND BIKE TRAIL PROJECT – Motion was made by Councilwoman Ford and seconded by Councilman Ginn on authorization to amend the interlocal agreement with Harris County to add an additional \$100,000 from the City of Deer Park for a joint Hike and Bike Trail Project.

Motion carried 6 to 0.

9. CONSIDERATION OF AND ACTION ON SUBMITTAL OF THE 2024 TAX ROLL AND THE CALCULATION OF THE NO-NEW REVENUE TAX RATE AND THE VOTER-APPROVAL TAX RATE – Motion was made by Councilman Martin and seconded by Councilman League on submittal of the 2024 Tax Roll and the calculation of the No-New Revenue Tax Rate and the Voter-Approval Tax Rate.

Motion carried 6 to 0.

10. CONSIDERATION OF AND ACTION TO INCREASE TOTAL TAX REVENUES FROM PROPERTIES ON THE TAX ROLL BY PROPOSING TO ADOPT A TAX RATE OF \$0.720000 PER \$100 VALUATION AT A FUTURE MEETING — Motion was made by Councilwoman Garrison and seconded by Councilwoman Ford to increase total tax revenue for the 2024 tax year by proposing to adopt a tax rate of \$0.720000 per \$100 valuation at a future meeting.

11. <u>CONSIDERATION OF AND ACTION ON THE ANNUAL REVIEW AND AN ORDINANCE ADOPTING THE CITY'S INVESTMENT POLICY</u> – After a proposed ordinance was read by caption, motion was made by Councilman League and seconded by Councilman Martin to adopt Ordinance No. 4546, captioned as follows:

AN ORDINANCE AMENDING THE DEER PARK CODE OF ORDINANCES BY REPLACING CHAPTER 2 (ADMINISTRATION), ARTICLE VII (FINANCE), ALL OF DIVISION 2 (INVESTMENT POLICY).

Motion carried 6 to 0.

12. <u>CONSIDERATION OF AND ACTION ON AN ORDINANCE CALLING A PUBLIC HEARING ON THE PROPOSED 2024 TAX RATE</u> – After a proposed ordinance was read by caption, motion was made by Councilman Ginn and seconded by Councilwoman Ford to adopt Ordinance No. 4547, captioned as follows:

AN ORDINANCE OF THE CITY OF DEER PARK SETTING THE DATE AND TIME FOR A PUBLIC HEARING OF THE PROPOSED PROPERTY TAX INCREASE FOR THE YEAR BEGINNING JANUARY 1, 2025. (September 17, 2024 at 7:30 p.m.)

13. CONSIDERATION OF AND ACTION ON AN ORDINANCE APPOINTING THREE MEMBERS OF THE CRIME CONTROL AND PREVENTION DISTRICT OF THE CITY OF DEER PARK – After a proposed ordinance was read by caption, motion was made by Councilwoman Garrison and seconded by Councilman Martin to adopt Ordinance No. 4548, captioned as follows:

AN ORDINANCE APPOINTING THREE (3) BOARD MEMBERS OF THE CRIME CONTROL AND PREVENTION DISTRICT OF THE CITY OF DEER PARK, TEXAS. (Bob Hotten, Victor White, Donald Zuckero)

Motion carried 6 to 0.

CONSIDERATION OF AND ACTION ON AN ORDINANCE APPOINTING ONE **MEMBER** TO THE PLANNING ALTERNATE AND ZONING COMMISSION/BOARD OF ADJUSTMENT TO COMPLETE UNEXPIRED TERM -After a proposed ordinance was read by caption, motion was made by Councilwoman Ford and seconded by Councilman Martin to adopt Ordinance No. 4550, captioned as follows:
