COMMENTS FROM AUDIENCE – No comments received.


1. APPROVAL OF MINUTES OF REGULAR BOARD OF ADJUSTMENT MEETING ON FEBRUARY 3, 2025 AND MINUTES OF THE PUBLIC HEARING HELD ON FEBRUARY 3, 2025. (CORONADO) – Motion was made by Commissioner Bryan and seconded by Vice Chairman Craft to approve the minutes of the Board of Adjustment meeting on February 3, 2025 and minutes of the Public Hearing held on February 3, 2025 (Coronado). Motion carried 5 to 0.
2. CONSIDERATION OF AND ACTION ON THE RESULT OF THE PUBLIC HEARING FOR BRADY THERIOT, A REPRESENTATIVE FOR WALMART, FOR AN EIGHTY (80) PARKING SPACE VARIANCE TO THE PARKING SPACE REQUIREMENT FOR A FOUR THOUSAND FOUR HUNDRED THIRTY SEVEN (4,437) SQUARE FOOT BUILDING EXPANSION FOR THEIR ONLINE PICKUP AT 9025 SPENCER HWY – Motion was made by Vice Chairman Craft and seconded by

Motion carried 5 to 0.

ON A REQUEST FROM KENNETH & MICHELLE DERRICK FOR A FIVE (5) FOOT VARIANCE TO THE LENGTH OF A CARPORT TO CONSTRUCT A CARPORT AT 1116 ALICE LANE – Motion was made by Vice Commissioner Melton and seconded by Commissioner Bryan to call a Public Hearing for April 7, 2025 at 6:20 pm. on a request from Kenneth & Michelle Derrick for a five (5) foot variance to the length of a carport to construct a carport at 1116 Alice Lane. Motion carried 5 to 0.

FROM MICHAEL WELDON FOR AN EIGHT (8) FOOT VARIANCE TO THE REAR BUILDING LINE TO CONSTRUCT A PATIO COVER AT 1501 CHEROKEE STREET – Motion was made by Vice Chairman Craft and seconded by Commissioner Bryan on calling a Public Hearing for April 7, 2025 at 6:20 pm. from Michael Weldon for an eight (8) foot variance to the rear building line to construct a patio cover at 1501 Cherokee Street. Motion carried 5 to 0.


ADJOURN – Chairman Cothran adjourned the meeting at 6:34 p.m.
