INVOCATION – The invocation was given by Commissioner Cothran.


COMMENTS FROM AUDIENCE – No comments received.

1. APPROVAL OF MINUTES OF REGULAR BOARD OF ADJUSTMENT MEETING ON MARCH 4, 2024 – Motion was made by Vice Chairman Cox and seconded by Commissioner Bryan to approve the minutes held on March 4, 2024. Motion carried 4 to 0.
2. CONSIDERATION OF AND ACTION ON THE RESULT OF THE PUBLIC HEARING ON THE REQUEST FROM DARREL PATE FOR A THREE (3) FOOT SIX (6) INCH VARIANCE TO THE SIDE BUILDING TO CONSTRUCT A CARPORT AT 701 LA NELL DRIVE – Motion was made by Secretary Cothran and seconded by Commissioner Bryan to approve the variance request from Darrel Pate for a three (3) foot six (6) inch variance to the side building to construct a carport at 701 La Nell Drive. Motion carried 4 to 0.
3. CONSIDERATION OF AND ACTION ON THE RESULT OF THE PUBLIC HEARING ON THE REQUEST FROM GABRIELLA DELA GARZA AND JORGE V. LEMUS FOR A SIX (6) FOOT VARIANCE TO THE FRONT BUILDING LINE TO CONSTRUCT A PATIO COVER AT 202 E. FORREST LANE – Motion was made by Vice Chairman Cox and seconded by Commissioner Bryan to approve the variance request from Gabriella Dela Garza and Jorge V. Lemus for a six (6) foot variance to the front building line to construct a patio cover at 202 E. Forrest Lane. Motion carried 4 to 0.



ON THE REQUEST FROM DOLORES KING FOR A TWENTY (20) FOOT VARIANCE TO THE SEPARATION OF A NEW DRIVEWAY TO BE CONSTRUCTED AT 7426 WEST TEMPERANCE LANE – Motion was made by Vice Chairman Cox and seconded by Secretary Cothran to schedule a public hearing on May 6, 2024 at 6:20 pm. on the request from Dolores King for a twenty (20) foot variance to the separation of a new driveway to be constructed at 7426 West Temperance Lane. Motion carried 4 to 0.
