AN ORDINANCE CREATING SECTION 2-262, UNDER CHAPTER 2-ADMINISTRATION – ARTICLE VII – FINANCE – DIVISION 1 – GENERALLY AND AMENDING APPENDIX B – SCHEDULE OF FEES, RATES AND CHARGES, CHAPTER 2 ADMINISTRATION, SECTION 2-300 TO CHANGE TO SECTION 2-262 OF THE CODE OF ORDINANCES OF THE CITY OF DEER PARK, TEXAS, TO INCLUDING PROCESSING FEES FOR CREDIT CARD AND ELECTRONIC CHECK TRANSACTIONS; PROVIDING FOR AN EFFECTIVE DATE; AND PROVIDING FOR SEVERABILITY

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DEER PARK:

WHEREAS, City Council is amending the processing fee section to allow for charging the person creating the transaction a processing fee for using a credit or debit card for the below listed types of payments.

NOW THEREFORE, BE IT ORDANIED BY THE CITY COUNCIL OF THE CITY OF DEER PARK TEXAS:

I.

That Section 2-262 under Chapter 2 – Administration – Article VII – Finance – Division I – Generally be created with the following language:

Sec 2-262 – Processing Fees

The fees listed in the Appendix B Schedule of Fees under Chapter 2 – Administration, Sec 2-262 will cover processing fee costs for using a debit or credit card for listed transactions plus other fees as noted.

II.

That Appendix B – Schedule of Fees, Rates and Charges, Chapter 2 – Administration, Section 2-300 be changed to Section 2-262 of the Code of Ordinances of the City of Deer Park is hereby amended in full to read as follows:
