AMENDMENT Texas Emergency Services Retirement System and City of Deer Park, Texas On Behalf of Deer Park Volunteer Fire Department

The Texas Emergency Services Retirement System (TESRS) and the City of Deer Park, Texas (Governing Entity), on behalf of the Deer Park Volunteer Fire Department (Participating Department), entered into a Contract effective January 1, 1978.
