Deer Park City Council Members:

I am writing to request a Specific Use Permit at 4325 W. Pasadena Blvd. Deer Park, Texas 77536, for Liberty Christian Classical Academy (LCCA). LCCA is a 501(c)(3) nonprofit corporation. Our school has leased the property from Living Water Church, and we anticipate opening for students in August 2026.

We will be enrolling students in grades Prekindergarten 4 to 6th for Monday thru Friday instruction. We anticipate an enrollment of 120 students, ages 4 to 12. Our lease is for the building on the southwest corner of the property. The building is currently E class according to Harris County, and it formerly had a preschool. The new roof and improved cosmetics of the building will benefit the street and surrounding neighborhood.

Our hope is to utilize the property to provide parents and children in Deer Park and the surrounding area with a classical Christian education opportunity as there are limited options for Christian education and no classical school in our community. Please consider granting our request to obtain a Specific Use Permit for our private Christian school.


