

**ORDINANCE NO. \_\_\_\_\_**

**AN ORDINANCE AMENDING THE 2024-2025 BUDGET FOR THE CITY OF DEER PARK, TEXAS, AND APPROPRIATING THE SUMS SET UP THEREIN TO THE OBJECTS AND PURPOSES THEREIN NAMED.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DEER PARK:**

**I.**

That the City of Deer Park's budget for the fiscal year ending September 30, 2025 was duly prepared and filed with the City Secretary, where it was available for inspection by any taxpayer.

**II.**

That the City of Deer Park's budget for the fiscal year ending September 30, 2025 does include contingency funds for unexpected expenditures in the General Fund.

**III.**

That the Automated Fingerprint Identification System used by the Police Department to fingerprint all arrestees will not be CJIS compliant as of October 14, 2025 due to Windows 10 no longer being supported.

**IV.**

That in order to receive and set up the new Automated Fingerprint Identification System prior to the CJIS compliance deadline, it is necessary to purchase the new system immediately. To fully fund the new system, a budget amendment for the Police Department for fiscal year ending September 30, 2025 to appropriate an additional \$27,000.00 is necessary.

**V.**

That funding for the amendment to the expenditures of the adopted budget of the Police Department for the fiscal year ending September 30, 2025 will include the amount of \$27,000.00 from the budgeted contingency funds of the General Fund, which is available for this purpose.

**VI.**

That the regular budget of the City of Deer Park, Texas, for the fiscal year ending September 30, 2025, be, and the same is hereby, in all respects finally approved and amended as so described and shall be, and is hereby, filed with the City Secretary of said City.

**VII.**

That the amounts specified are for the purposes named in said budget, and they are hereby appropriated to and for such purposes.

**VIII.**

That the City Secretary file copies of this Ordinance and of such budget with all public officers as required by the laws of the State of Texas.

**IX.**

It is hereby officially found and determined that the meeting at which this Ordinance was adopted was open to the public, and that public notice of the time, place and purpose of said meeting was given, all as required by Chapter 551 of the Government Code of the State of Texas.
