Chairman Cothran opened the public hearing at 6:20 pm and directed the Board/City Secretary to read the Notice of Public Hearing (Exhibit A) and instructed the applicants to present their requests to the Board.

Chairman Cothran called three times for those in favor of the variance request.

1. Adam Barnes, DDG Firm, 2334 Poinsietta Drive, Houston Texas spoke on Walmart proposing a 4,437 square foot expansion to the online pickup area. Along with the expansion, an additional 36 parking stalls will be installed. Due to the building expansion reducing the total parking count from 987 to 972, Mr. Barnes explained that the city requires 1052 parking stalls which is the reason for the variance request to add 80 parking stalls to meet those requirements.

Chairman Cothran called three times for those in opposition of the variance request with none present.
