AN ORDINANCE AMENDING SECTION 74-1 OF THE CODE OF ORDINANCES OF THE CITY OF DEER PARK, TEXAS, PROVIDING HOURS FOR PARKS AND RECREATION FACILITIES; CORRECTING AND ADDING PARK ADDRESSES; PROVIDING FOR PENALTY; AND PROVIDING FOR SEVERABILITY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DEER PARK:

- 1. That Chapter 74 Parks & Recreation, Section 74-1, hours for certain parks and recreation facilities, be replaced with the following:
- (a) It shall be unlawful for any person to enter into or upon any of the parks and recreation facilities designated in subsection (b) of this section between the following hours and days:
 - (1) 11:00 p.m. to 5:00 a.m. on Fridays and Saturdays.
 - (2) 10:00 p.m. to 5:00 a.m. on Sundays through Thursdays.
 - (3) Exceptions approved by the City's Parks and Recreation Director may be granted in certain circumstances.
- **(b)** This section applies to the following parks and recreation facilities:

(c) Any person who shall violate the provisions of this section, or who shall fail to comply herewith, or with any of the requirements hereof, shall be guilty of a misdemeanor and shall be liable to a fine of not more than \$200.00 upon conviction.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DEER PARK, TEXAS:

- 1. That the City Council of the City of Deer Park hereby amends in its entirety Section 74-1 as listed above.
- 2. This Ordinance applies only to offenses committed on or after its effective date, and an action for an offense committed before this Ordinance's effective date is governed by the Ordinance existing before the effective date, which Ordinance is to be continued in effect for this purpose as if this Ordinance was not in force.
- 3. Publication and Effective Date. This ordinance shall be effective upon adoption and publication of this ordinance or a caption that summarizes the purpose of this ordinance and the penalty for violating this ordinance published at least one time within ten days after final passage in the City's official newspaper per City Charter, Sec. 2.06(g)(A).

4. If any provision of this Ordinance or the application thereof to any person or circumstances is held invalid, such invalidity shall not affect other provisions or applications of this Ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this Ordinance are declared to be severable.

5. It is officially found and determined that the meeting at which this Ordinance was adopted was open to the public, and that public notice of the time, place and purpose of said meeting was given, all as required by Chapter 551 of the Government Code of the State of Texas.
