## **ORDER NO. CCPD 2025-02**

AN ORDER OF THE CITY OF DEER PARK CRIME CONTROL AND PREVENTION DISTRICT CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE MAY 3, 2025 ELECTION FOR CONTINUATION OF THE CITY OF DEER PARK CRIME CONTROL PREVENTION DISTRICT FOR TWENTY (20) YEARS; MAKING FINDINGS OF FACT; PROVIDING FOR SEVERABILITY; AND MAKING OTHER PROVISIONS RELATED THERETO.

NOW, THEREFORE, BE IT ENACTED BY ORDER OF THE BOARD OF DIRECTORS OF THE CITY OF DEER PARK CRIME CONTROL AND PREVENTION **DISTRICT:** 

**Section 1**. Pursuant to Section 363.2515 of the Texas Local Government Code, the Board of Directors of the City of Deer Park Crime Control and Prevention District requested a referendum on the continuation of the City of Deer Park Crime Control and Prevention District at the municipal election on May 3, 2025 as Proposition B.

The Board of Directors of the City of Deer Park Crime Control and Section 2. Prevention District finds the election for the continuation of the City of Deer Park Crime Control and Prevention District for twenty (20) years was duly called; that notice thereof was given in accordance with law; that said election was held in accordance with the law; that the returns of said election have been made by the proper officers, and canvassed by the Board of Directors of the City of Deer Park Crime Control and Prevention District.

**Section 3.** On the May 3, 2025 municipal election, the following votes were cast for the continuation of the City of Deer Park Crime Control and Prevention District for twenty (20)

That the City of Deer Park Crime Control and Prevention District is continued for twenty (20) years after the current term expires in May 2026.

<u>Section 3</u>. All orders or parts of orders in force when the provisions of this Order becomes effective which are inconsistent or in conflict with the terms and provisions contained in this Order are hereby repealed only to the extent of any such conflict.

Section 4. It is hereby declared to be the intention of the Board of Directors that the phrases, clauses, sentences, paragraphs and sections of this ordinance be severable, and if any phrase, clause, sentence, paragraph or section of this Order shall be declared unconstitutional by the valid judgment or decree of any court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs or sections of this ordinance, and the remainder of this Order shall be enforced as written.

Section 5. The District Secretary is hereby authorized and directed to send to the Comptroller for the State of Texas by United States certified or registered mail a copy of this order.

**Section 6.** This Order shall take effect immediately upon its passage.
