AN ORDINANCE AMENDING APPENDIX (B), OF CHAPTER 34, SECTION 34-25, OF THE CODE OF ORDINANCES OF THE CITY OF DEER PARK, PROVIDING NEW FEES FOR EMERGENCY AMBULANCE SERVICE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DEER PARK:

I.

Appendix (B), Chapter 34, Section 34-25, of the Code of Ordinances of the City of Deer Park, is hereby amended so that it shall hereinafter read as follows:

Fees for Emergency Medical Services

Appendix(B), SECTION 34-25.

The EMS Chief or his delegated representative shall provide for the orderly maintenance of records and information relative to the costs to the city of the operation of such city emergency ambulance service. Rates and fees to be charged for each call for emergency ambulance service shall be as follows:
