



Awarding Request for Proposal for professional auditing services.

Summary: Pursuant to state statute and City ordinance, the City shall have its records and accounts audited annually and shall prepare an annual financial statement and report. The audit shall be performed by a certified public accounting (CPA) firm, licensed to practice in the State of Texas. Belt Harris Pechacek, LLLP has served as the City's auditors for the last five years beginning with the fiscal year 2013 audit and concluding with the fiscal year 2017 audit, which was presented to City Council at the March 20, 2018 meeting. At least every five years, the request for proposal process is initiated to review and evaluate all qualified firms interested in providing these services to the City of Deer Park. Facing completion of the existing five-year contract term, the City issued a Request for Proposal for professional auditing services following authorization at the February 20, 2018 City Council meeting. The City received seven (7) responses as follows: Belt Harris Pechacek, LLLP; BKD, LLP; Haynie & Company (formerly Darilek Butler & Associates, PLLC); Pattillo, Brown & Hill, LLP; Postlethwaite & Netterville, Weaver and Tidwell, LLP; and Whitley Penn, LLP.

As discussed in the workshop prior to this meeting, the City evaluated the responses based on qualifications and experience, technical ability, references for similar governmental entities, and thoroughness of the response. The top two firms were then evaluated on estimated pricing, which represents 10 percent of the final score. Following the evaluation of the responses, Belt Harris Pechacek, LLLP was identified as the highest ranking firm based on the total score, and the City staff recommendation is to award the engagement to this firm. The initial three-year period for the contract will begin on June 1, 2018 and will cover the annual audit for the fiscal years ending September 30, 2018 through 2020. The contract will include the option to extend the engagement an additional two years to also include the annual audit for the fiscal years ending September 30, 2021 and 2022 (for a total of five years).

Fiscal/Budgetary Impact:

Professional auditing services were included in the proposed Fiscal Year 2017-2018 Finance Department budget in the amount of \$35,000 (Account Number 10-201-4239, Audit Fees).

In 2013, the City last issued an RFP for professional auditing services for the fiscal years 2013-2017, a total of five years, with the last two years representing optional renewals. At that time, Pattillo, Brown & Hill, LLP had provided auditing services to the City for the fiscal years 2004 - 2012, a total of nine years. Following the RFP process in 2013, Belt Harris Pechacek, LLLP was awarded the contract and with the conclusion of the audit for fiscal year 2017, the firm completed the maximum five-year term of the agreement.

It is typical that these types of professional services are revisited at least every five years using a process to request proposals from qualified firms. On February 21, 2018, following City Council approval, the City issued an RFP for professional auditing services. As before, the process allowed interested firms the option to attend a pre-submittal meeting to ask questions with a final deadline of March 16, 2018 for technical questions. The submission deadline for proposals was April 2, 2018. Representatives from two firms attended the pre-submittal meeting (indicated by a "*" in the following list), and seven firms responded to the RFP: Belt Harris Pechacek, LLLP; *BKD, LLP; Haynie & Company (formerly Darilek Butler & Associates, PLLC); Pattillo, Brown & Hill, LLP; *Postlethwaite & Netterville, Weaver and Tidwell, LLP; and Whitley Penn, LLP.

Overview

The RFP stressed the importance of municipal experience, particularly with cities similar in size to Deer Park. Responses were evaluated based on established criteria with greater emphasis on qualifications, experience, and technical ability to underscore the importance of factors other than cost as the basis for any decision. Respondents were asked to submit a separate cost proposal, with cost representing a maximum 10 percent (10%) of the score.

The RFP included the following evaluation criteria: "The evaluation of the proposals will be made based on the criteria listed below. While pricing is a consideration, it is clearly not the primary factor in the selection of the firm. The contract award will not necessarily be made to the firm that provides the lowest cost proposal. The contract award will be based primarily on demonstrated competence and qualifications using the listed criteria. It is important that the proposal be clear and complete. Incomplete responses will not be considered under any circumstances." Memo to Jay Stokes & Gary Jackson May 3, 2018 Page 2

The goal of the RFP process is to select a qualified certified public accounting firm to perform the annual audit for the fiscal years ending September 30, 2018 through 2020, with an option to extend the engagement an additional two years to also audit the fiscal years ending September 30, 2021 and 2022. The selected firm must express an opinion on the fair presentation of the City's general purpose financial statements and combining and individual fund financial statements in conformity with generally accepted accounting principles. As part of the audit, the firm shall perform certain limited procedures involving required supplementary information required by GASB. The firm shall also be responsible for preparation of the CAFR and shall work with the City to ensure the report will qualify for the GFOA Certificate of Achievement for Excellence in Financial Reporting award program. The firm shall also perform and report on single audits, as needed. The firm shall be required to present the annual audit to the Finance Committee and the City Council. Additionally, the firm shall be responsible for performing the necessary agreed upon procedures related to the financial assurance test required by the TCEQ in conjunction with the City's solid waste facility. The firm must also be available to respond to other accounting or auditing needs throughout the year, such as providing professional expertise and assistance during the bond issuance process.

Evaluation

A copy of the evaluation results is attached. Based on the responses to the RFP, I believe most of the firms are qualified to provide these services, however I believe two firms stand out as best suited to satisfy the City's requirements.

Cover Letter

Each firm submitted the required cover letter indicating the firm's understanding of the engagement (or aspects thereof) and why the firm is qualified to perform the services. These letters included various degrees of information and all but one were signed by a person authorized to contractually bind the firm. One letter was simply signed with the firm name, which to me, does not represent a "binding signature." Three of the responses were from firms in Houston, one was from a firm in Baton Rouge, LA but with a Houston office (most of the team is in Louisiana), one was from a firm in the Houston area (Conroe), and two firms planned to conduct the audit from offices in San Antonio or Waco.

Qualifications and Experience

All firms have some level of experience with governmental audits and are able to provide other audit services, if requested. The distinction is in the size of the firm, how long they have been serving municipal clients and the size and type of the representative client base (i.e., cities), particularly cities similar in size to Deer Park and in some cases, cities in the State of Texas. Each firm took a different approach to describing their organizational/staffing structure and introducing the audit team that would be assigned to the City. All firms and staff are licensed to practice in the State of Texas although the firm in Louisiana did not clarify that point. One firm provides exclusive service to auditing local governments, and other firms have a dedicated group serving only governmental clients. Each team offers a different level of experience, but most of the engagement partners have extensive experience working with governmental audits.

Technical Approach and Understanding of Scope of Work

All of the firms have an understanding of the required scope of work to complete the annual audit for the City although not all firms referenced the agreed-upon procedures related to the TCEQ requirement for the solid waste facility. Two firms made a specific reference to the City's Incode system and only one firm indicated experience with industrial districts. Each included some level of detail about a project plan for the engagement outlining major tasks and responsibilities and associated staffing. Certainly the responses with more detail provided the most useful information to the City regarding their approach and expectation for the audit. One firm indicated "if" relative to interim fieldwork (there is no "if" relative to interim fieldwork) and their particular timeline seemed a bit unusual.

Thoroughness of Response/Reviewer Observations

Most of the responses were organized and easy to follow, however, all of them had something missing. The RFP required a hard copy and an electronic copy of both the response and the cost proposal. All but one firm sent two separate thumb drives, as required, but one firm sent both proposals on the same thumb drive. One firm sent thumb drives that were password protected, rendering them unusable. One firm requires a background check of the person (typically the finance director) signing the client rep letter. I find this objectionable, and I am not agreeable to providing my personal information to this firm. One firm recently merged with a Texas firm, which gives me pause about continuity in the Texas team currently in place. One firm cited an exception related to release of work papers. Two firms did not provide all the requested insurance information.

References

All firms provided a minimum of four references. In order to complete the evaluations, the City developed a questionnaire and emailed it to four references for each firm hoping for at least three to be returned. The City received anywhere from one to three responses. It is not likely that any firm will provide an unfavorable reference, but some references provided more complete and/or candid feedback.

Certification and Acknowledgement

The RFP included a requirement that an appropriate representative, duly authorized to execute the contract, sign a certification and acknowledgement stating such and as well to affirm agreement to all terms and conditions contained in the RFP. All firms executed this document.

Additional Forms

The RFP stated that respondents must include executed copies of the Conflict of Interest Questionnaire (Form CIQ) and the Certificate of Interested Parties (Form 1295), both available on the Texas Ethics Commission website (links were included in the RFP). One firm did not provide Form 1295.

Addenda

There were no addenda items applicable to this RFP.

Scoring and Ranking

The overall evaluation resulted in the following ranking of the respondents prior to consideration of the cost proposal:

- 1. Belt Harris Pechacek (89)
- 2. BKD (83)
- 3. Weaver and Tidwell (78)
- 4. Pattillo, Brown & Hill (77)
- 5. Whitley Penn (75)
- 6. Postlethwaite & Netterville (64)
- 7. Haynie & Company (62)

Conclusion and Recommendation

After consideration of the cost proposal, evaluated for the two top ranked firms only, the scoring indicated Belt Harris Pechacek as the top firm (a copy of the scoring sheet is attached). My recommendation is that Belt Harris Pechacek, LLLP continue to provide professional auditing services to the City for the next five-year term. The firm works exclusively on governmental audits, has a large municipal client base in the Houston area, and has served the City well for the past five years. Tara Riley did an informal review of the responses and is also in agreement that Belt Harris Pechacek, LLLP is the best choice for the City.

- 1. <u>MEETING CALLED TO ORDER</u> Mayor Mouton called the workshop to order at 5:45 p.m.
- 2. <u>DISCUSSION OF ISSUES RELATING TO INCENTIVES OFFERED UNDER THE TEXAS ENTERPRISE ZONE PROGRAM AND NOMINATING TWO SHELL PROJECTS AS ENTERPRISE PROJECTS</u> Assistant City Manager, Gary Jackson gave an overview of the incentives offered under the Texas Enterprise Zone Program and nominating Shell as an Enterprise Project for the City of Deer Park. There are two additional nominations in process. The Governor's office reviews the points from the local companies applying for the projects. The project, from the Shell Deer Park Refining L.P., is a retention project of 500 jobs and a \$250 million investment. The other, is for Shell Chemical, a \$150 million retention project with a retention of 500 jobs. It was recommended to call for a Public Hearing to amend the incentives that are currently in effect and to offer three additional incentives. Mr. Jackson introduced Eric Gysler with Economic Incentives, Inc. to answer any questions.

Mr. Gysler commented, "Mayor, Council, I am Eric Gysler and I work with Economic Incentives and I am assisting Shell along with the City in this effort. This is a State program that offers sales and use tax refunds to companies that create or retain jobs and make capital investments. It does not cost the City any money, it is a state incentive for a

6.25% of sales tax refund, based on the jobs they create or retain and the amount of investment that they make in the 5 year designation period. Nowadays, a company has to make application in a quarterly filing period. The State only gives away 12 of these designations each quarter. They are competitive, so when Shell submits its application in June, it will be competing against the other applications throughout the State. We are asking for today, is to add these additional incentives to your list in your Enterprise Zone Ordinance so that companies in Deer Park can have the most points that they can get from these particular sections of the application on behalf of the City. There is no obligation to give it to any project. It would be advantageous on the City's behalf if you would approve these, to make projects within Deer Park more competitive against the others in the State."

Mayor Mouton commented, "We always appreciate our industry partners in every aspect of our businesses in the Community."

- 3. <u>EXECUTIVE SESSION- CONSULTATION WITH CITY ATTORNEY POTENTIAL</u> <u>LITIGATION</u> – Mayor Mouton recessed the meeting at 5:52 p.m. for an Executive Session.
- 4. <u>RECONVENED</u> Mayor Mouton reconvened the workshop meeting at 6:13 p.m.
- 5. <u>DISCUSSION OF ISSUES RELATING TO THE SATURDAY DROP-OFFS AT THE</u> <u>TRANSFER STATION</u> – City Manager, Jay Stokes discussed the concerns pertaining to the dramatic increase in material drop-offs on Saturdays. The Saturday drop off service is intended to serve only Deer Park residents who are disposing of their own materials. It appears some residents acting as commercial haulers are disposing of building materials such as sheetrock, masonry, etc. every week. There are materials being dropped off by people that are not residents of Deer Park. As commercial-type drop offs have increased, so have wait times on Saturday mornings. Many residents have expressed concern about waiting hours to drop off their materials on Saturday mornings due to delays from commercial haulers.

Sanitation Supervisor, Ben Alexander, commented, "The transfer station depository site was originally designed over 30 years ago to allow the homeowner to bring heavy trash from their own property to the transfer station instead of waiting for heavy trash day. It was an added convenience to the citizens. Thirty years ago, we were averaging about 30 people in an 8 hour period. Lately, more and more people have started to participate and now we are averaging 160 people per Saturday. My guys have been telling me over time that we are getting more contractors coming into the building. The contractors are pretty bold with the way they handle their business. They come in with plaquards on the side of their trucks, we tell them they cannot dump. They then pull out of the building, take the plaquards off of their truck and come back in to say, they are Deer Park citizens, and we have to let them dump. Since this is our rule, and their identifications show they are indeed a Deer Park resident, we let them dump. I am not sure if it is because of these storms that we have had over the last ten years or so, but the contractors are now bypassing the residents that come. These people are bringing in commercial size trailers and you can clearly tell the type of waste that they are bringing is commercial."

Mr. Alexander provided photos to show the issues with Saturday drop-offs.

After a discussion, the consensus of the Council is to limit the residents to single axle trailers with restrictions to the size of trailer to take effect on June 1, 2018.

6. <u>DISCUSSION OF THE PRATT TRUSS BRIDGE STRUCTURE AT THE</u> <u>BATTLEGROUIND GOLF COURSE</u> – City Manager, Jay Stokes spoke of the letter sent to the Historical Commission to ask for input or any documents from their archives regarding any maintenance obligations the City might have to the bridge due to the bridge having a Historical Marker. The response from the Historical Commission to the City, was that the City has control of what can be done with the bridge. Cost estimates for the three options are the same as what was previously presented to Council. Guidance was asked from the Council on how to proceed. RPS was in attendance to answer any questions.

Mayor Mouton commented, "Let's try to define where we are. With any facility or any assets of the City, we do the best we can to maintain it. That does not mean there is an obligation that at all costs we have to maintain it. We need to clarify the conclusion, that there was an intent that we agreed to maintain the bridge. What Staff and RPS has done is try to clarify any alleged documentation that shows what we should or should not adhere too. It still does not remove the fact the City signed this agreement with the intent to maintain the bridge. The ultimate responsibility still falls with us whether we spend the money and maintain it or we don't. As I said before, this has always been a hot topic. It is really not that complicated. We, either allocate the funds to fix the bridge, maintain the bridge or we don't. The fact is there is not an obligation for the City to do anything, we have the control, as Council, to decide what we need to do. City Staff is waiting for direction."

Jonathan Griffin, RPS, gave an overview of the options available for the bridge, with Option 1 - repairing the bridge's historic truss structure, Option 2 - replacing the truss structure with a similar type structure for the historic appearance of the bridge, Option 3 - removing the structure all together. With Options 2 and 3, the historical markers would have to be returned.

After a lengthy discussion, Mayor Mouton asked for a vote from Council for their preferred Option choice.

Councilwoman Garrison voted for Option 1 Councilman Harrison voted for Option 1 Councilman Ginn voted for Option 1 Councilman Patterson voted for Option 1 Councilman Martin voted for Option 2 Councilwoman Sinor voted for Option 3

The consensus of the Council is to authorize Staff to enter into a contract with RPS for Option 1.

- 7. DISCUSSION OF ISSUES RELATING TO AMENDMENT NO. 2, THE INTERLOCAL AGREEMENT WITH THE HARRIS COUNTY FLOOD CONTROL DISTRICT FOR THE RECONCILIATION OF FINAL COSTS OF THE PROPERTY ACOUIRED FOR THE PATRICK'S BAYOU STORMWATER DETENTION BASIN – Assistant City Manager, Gary Jackson, advised the Council the conclusion of the land acquisition of the condemnation of the property for the Patrick's Bayou Detention. The City partnered with the Harris County Flood Control District (HCFCD) a decade ago to create the Patrick's Bayou Detention Basin. The property was not able to be acquired through purchase, it had to go to imminent domain proceedings. In 2014, that led to a verdict that the fair market price at the time of condemnation should have been \$11,636,238. There was additional interest owed in the intervening years of another \$557,945.85, as well as court costs of \$53,678.64. In 2014, Harris County appealed the decision of Harris County Court of Law No. 2 to the 14th Court of Appeals. In 2016, the appellate court upheld the lower court's decision. During the appeals process, another \$306.816.52 of interest accrued. The time now is upon the City to pay half of these additional costs. HCFCD previously paid all of these costs, and the need to reimburse the City's portion which is \$1,777,339.51. This expense will be funded via our 2010 Certificates of Obligation which were borrowed specifically
- 8. <u>DISCUSSION OF ISSUES RELATING TO THE PURCHASE AND INSTALLATION OF FIVE (5) ELECTRONIC MARQUEE MESSAGE SIGNS FROM NATIONAL SIGNS</u> Assistant City Manager, Gary Jackson, presented some photos to show the signs that have been put up and lit. National Signs provided three crews to install the five (5) signs and finished the project several weeks earlier than anticipated. The City will be providing the electrical connection and landscaping. The project cost came in at \$29,000 less than what was budgeted (13% savings). The savings were due to discounts received from National Signs from their suppliers (for the five signs) and those savings were passed on to the City. Staff and Council were very pleased with the professionalism, training, support and products that the National Signs team provided.

Rebecca Bruce of National Signs, commented, "We just did the City Hall interior signs as well. We are also doing the Police Training facility in about two weeks. They will be getting an interior badge sign similar to City Hall signage. I know that our IT Department has been coordinating with IT Director, James Lewis, to get the rest of the signs illuminated and we should have all of it done by next week. We look forward to building this relationship with you all."

9. <u>DISCUSSION OF ISSUES RELATING TO THE CURRENT STATUS OF DPCDC</u> <u>PROJECTS</u> – Parks and Recreation Director, Charlie Sandberg, gave an update on the Dow Park Pavilion, Maxwell Adult Center, Girls Softball Renovations and the new Soccer Complex projects. Council was advised that the Spencerview Project is now completed. Mr. Sandberg gave a detailed report for each project and their current status and answered Council's questions. a. Frank Walker, 3713 Garrett Boulevard commented, "Good evening. I have three concerns. Lack of streetlights on Pasadena Boulevard traveling eastbound after East Boulevard headed to Underwood. In traveling to City Hall tonight on East Boulevard, between P Street and San Augustine, I counted 10 on each side of East Boulevard for a total of 20. Possibly not even a half of a mile distance. On Pasadena Boulevard, there is one street light at the entrance to the softball fields and there is one at the street of Clover and Garrett. All three of these are outdated and could be upgraded or repaired. Number two, street striping on Pasadena Boulevard. Other than the yellow divider to signify that you have south and north on Pasadena Boulevard, the traffic dividers in the lanes are

either nonexistent or very few. It would be a good strategy, I believe, to have those implemented. I ask you, Mayor, and Council at your leisure, to drive down Pasadena Boulevard headed to East Boulevard, preferably on a night, that there are no softball games, no lights going on at the complex, observe what light is on the street, and compare it to East Boulevard, Center Street or Luella. The sidewalks are my final concern. On either side of Pasadena Boulevard, there are no sidewalks for pedestrians or bicyclists. The softball fields are City maintained with the Parks crew mowing them. The City put in sidewalks there, but currently there are no baseball games being played. People are walking from the church to the softball fields, crossing Pasadena Boulevard and walking in the ditch to get to the complex. Doesn't sound like a good plan. I know it is new, but I know we can do something to present them with a sidewalk to walk on so it is a little safer. I ask this as a citizen of Deer Park, please don't forget us in La Porte outlot subdivision. Thank you for your time.

Acceptance of Quarterly Investment Report (January - March 2018).

Summary: Chapter 2, Administration, Article VII (Finance), All of Division 2 (Investment Policy), Section 2-274 Reporting, of the Code of Ordinances of the City of Deer Park, requires the Investment Officers to prepare and submit to City Council an investment report no less than on a quarterly basis. This requirement is in compliance with the Texas Public Funds Investment Act, V.T.C.A., Government Code Ch. 2256 as amended (the "Act"). The City's Investment Officers have worked with the Investment Advisor to prepare and have signed this report for the quarter ended March 31, 2018.

At March 31, 2018, all City funds were held in various depository accounts or in accounts at TexPool or TexSTAR, which are local government investment pools authorized by the Investment Policy. Both pools continue to maintain their AAAm rating by Standard & Poor's, which is the highest rating a local government investment pool can achieve.

Cash and investment activity included on the attached report is summarized below:

Working with the City's investment advisor, the City has diversified the portfolio during the past year with current investments of \$41,952,035 in various depository banks through money market accounts and certificates of deposit. These investments represent about 35 percent of the portfolio.

These depository investments are earning between 1.20% and 2.20%. Comparatively, rates in the investment pools averaged 1.3861% and 1.3804% for the quarter in TexPool and TexSTAR, respectively. The new depository investments have increased investment earnings, and the City continues to review and evaluate investment opportunities for safety, liquidity, and yield.

At the end of the second quarter of Fiscal Year 2017-2018, investments in TexPool totaled \$30,541,216, which is a net decrease of \$93,384 from the previous quarter. This net decrease represents a transfer from the Deer Park Community Development Corporation bond funds for Type B project expenditures offset by interest earnings for the quarter. The TexPool funds earned an average 1.3861% for the quarter (January - March) or 29.98 basis points higher than the average for the previous quarter (note: a basis point is equal to 1/100 of a percentage point so 0.01 equals 1 basis point). On March 31, 2018, TexPool was earning 1.6444%.

Investments in TexSTAR at the end of the second quarter of the fiscal year totaled \$29,617,921, which is a net increase of \$100,654 from the previous quarter. This increase represents interest earnings for the quarter. The TexSTAR funds earned an average 1.3804% for the quarter or 28.24 basis points higher than the average for the previous quarter. On March 31, 2018, TexSTAR was earning 1.6187%.

The federal funds rate, still shown as a range, was last increased in March 2018 to 1.50% - 1.75% (from the previous 1.25% - 1.50%). As a result of market changes, the City continues to see higher interest earnings. The 1.33% weighted average yield for the second quarter ended March 31, 2018 is below the 1.58% rolling average yield of the three-month U.S. Treasury Bill for the quarter. The City's weighted average yield for the fiscal year-to-date at March 31, 2018 is 1.18%, which is 15.0 basis points higher than the previous quarter. Currently about 15.7 percent of the portfolio is in the City's depository bank.





Consideration of and possible action to terminate to the contract with South Pools, Inc. for the Dow Park Pavilion and Improvements project (DPCDC project).

The Dow Park Pavilion and Improvements project is a Deer Park Community Development Corporation (DPCDC) project funded by the dedicated one-half of one percent Type B economic development sales tax. The project was awarded to South Pools, Inc. on February 21, 2017 in the amount of \$617,737.50. Council later approved Change Order #1 on June 26, 2017, in the amount of \$80,484.60. On February 1, 2018, the City and South Pools, Inc. agreed to Change Order #2 in the amount of \$51,775.66, conditioned upon the contractor completing all work within an additional 100 calendar days from the date of the change order. This additional 100-day period ends on May 12, 2018.

Over the past several months, the contractor has failed to complete this work in timely fashion. On April 12, 2018, the City's construction attorney sent the contractor's attorney notice that if South Pools does not perform and complete all of its work by the agreed completion date, the City will terminate South Pools right to continue its performance on the Project. The notice also stated that should termination be required, it will be voted on by Council at the May 15, 2018 Council Meeting.

The contractor has continued to work on the project and for the past two (2) months, City staff has conducted weekly construction progress meetings with the contractor. Although progress has been made, it does not appear at this writing that the project will be 100% complete by May 12, 2018. This item on the agenda will allow City Council to consider and take appropriate action regarding the contract with South Pools, Inc. Should the contract be terminated, the City would have to contract with another vendor and/or complete the balance of the work with in-house force account labor. Alternatively, if the project is very close to completion but not 100% complete, Council may wish to consider a short extension.

Consideration of and action on renewing the contract with KHSS Ventures, Inc. (DBA Skillet's Restaurant) for the Senior Meals program.

Summary:

Last June 28, the City entered into a one-year contract with KHSS Ventures, Inc. (DBA Skillet's Restaurant) to provide congregate and home-bound meals for senior citizens through the Maxwell Center. The contract expires on July 31, 2018 and includes the option to renew annually for up to two (2) more additional years. Last year the City agreed to increase the cost per meal by 8 percent (8%). At this time, both the City and Skillet's Restaurant are agreeable to another one-year extension of the contract. Due to the continuous rise in the cost of raw products, especially beef and produce, and increasing labor costs, Skillet's Restaurant has proposed a 5 percent (5%) increase for the meals as shown below:

The cost per meal in 2017 was as follows:

Home-bound meals = 100 meals @ \$5.38/meal

Congregate meals = 40 meals @ \$4.84/meal

The cost per meal proposed for 2018 is as follows:

Home-bound meals = 100 meals @ \$5.65/meal

Congregate meals = 40 meals @ \$5.08/meal

Home-bound meals averages 65-70 meals, but to be conservative, the higher amount is used for bid purposes.

All meals are served with one meat, two sides, bread and dessert, and each home bound meal includes a beverage (milk or juice). Because of the Maxwell Center renovations, the congregate meals are being packaged and delivered the same way as the home-bound meals to facilitate delivery and service to the Community Center. At this time and until the Maxwell Center is re-opened and the normal congregate meal delivery and service is restored, the congregate meals will be provided at the same price as the home-bound meals.

Fiscal/Budgetary Impact:

The Senior Meals Program is included in the FY 2017-2018 Budget for Senior Services (Account Number 10-415-4303, Operational Supplies).

Designated projects are eligible to apply for state sales and use tax refunds on qualified expenditures. Qualified expenditures include building materials, machinery and equipment, electricity, gas and tangible property purchased and consumed in the normal course of business, and taxable services.

The level and amount of refund is related to the capital investment and jobs created at the qualified business site. In addition, local communities must offer incentives to participants under the Enterprise Zone Program, such as tax abatement, tax increment financing, one-stop permitting, and other incentives developed by participating communities.

Communities may nominate projects for a designation period up to five years, not including a 90-day window prior to the application deadline. Employment and capital investment commitments must be incurred and met within the five-year time frame.

The Enterprise Zone program is very competitive and the selections are made on a point rating system. The more incentives, the more points the nomination scores in the selection process. Local incentives are established by city ordinance. The City previously listed incentives in 2009 by Ordinance #3302 and in 2011 by Ordinance #3419. The City has previously sponsored three Enterprise Zone nominations for the following local businesses; Shell Refinery, Lubrizol, Rohm & Haas Texas, Inc.

The proposed ordinance would add the following new incentives:

- A. Local Sales Tax Refunds (2 pts. If included in ordinance; 4 pts. If actually delivered to the project)
- B. Other tax deferrals, tax refunds or tax incentives (2 pts. If included in ordinance; 4 pts. If actually delivered to the project)
- C. Provision of publicly owned land for development purposes (1 pts. if included in ordinance; 4 pts. If actually delivered to the project)

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF DEER PARK AUTHORIZING THE CITY'S PARTICIPATION IN THE TEXAS ENTERPRISE ZONE PROGRAM PURSUANT TO THE TEXAS ENTERPRISE ZONE ACT, CHAPTER 2303, TEXAS GOVERNMENT CODE (ACT), PROVIDING TAX INCENTIVES, DESIGNATING A LIAISON FOR COMMUNICATION WITH INTERESTED PARTIES, AND NOMINATING THE LUBRIZOL COMPANY TO THE OFFICE OF THE GOVERNOR ECONOMIC DEVELOPMENT & TOURISM (EDT) THROUGH THE ECONOMIC DEVELOPMENT BANK (BANK) AS AN ENTERPRISE PROJECT (PROJECT); AND DECLARING AN EMERGENCY.

WHEREAS, the City Council of the City of Deer Park, Texas (City) desires to create the proper economic and social environment to induce the investment of private resources in productive business enterprises located in severely distressed areas of the City and to provide employment to residents of such area; and

WHEREAS, the project or activity is not located in an area designated as an enterprise zone; and

WHEREAS, pursuant to Chapter 2303, Subchapter F of the Act, the Lubrizol Company

has applied to the City for designation as an enterprise project; and

WHEREAS, the City finds that the Lubrizol Company meets the criteria for tax relief and other incentives adopted by the City on the grounds that it will be located at the qualified business site, will create a higher level of employment, economic activity and stability; and

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DEER PARK, TEXAS THAT:

Section 1: The City nominates the Lubrizol Company for enterprise project status.

Section 2: The following local incentives, at the election of the governing body, are or will be made available to the nominated project or activity of the qualified business:

- a) If located within the city limits of the City of Deer Park, the City may abate taxes on the increase in value of real property improvements and eligible personal property that locate in a designated enterprise zone. The level of abatement shall be based upon the extent to which the business receiving the abatement:
 - creates jobs for qualified employees, in accordance with the City of Deer Park's Tax Abatement Policy, and with qualified employee being defined by the Act and,
 - 2) creates new additional value of eligible property improvements in an amount equal to or greater than the amount established by the City Council as a minimum.
- b) If located in the City's extraterritorial jurisdiction, the City may enter into an industrial district contract which provides for in-lieuof tax payments to the City.
- c) If located in the City, the City may provide regulatory relief to businesses, including:
 - 1) exemptions from certain inspection fees; or
 - 2) streamlined permitting.
- d) If located within the City, the City may provide business and industrial development services, including creation of special one-stop permitting and problem resolution process or ombudsmen.

Section 3. The enterprise zone areas within the City are reinvestment zones in accordance with the Texas Tax Code, Chapter 312.

Section 4. The City of Deer Park City Council directs and designates its Assistant City Manager as the City's liaison to communicate and negotiate with the EDT through the Bank and enterprise project(s) and to oversee zone activities and communications with qualified businesses and other entities in an enterprise zone or affected by an enterprise project.

Section 5. The City finds that the Lubrizol Company meets the criteria for designation as an enterprise project under Chapter 2303, Subchapter F of the Act on the following grounds:

- a) The Lubrizol Company is a "qualified business" under Section 2303.402 of the Act since it will be engaged in the active conduct of a trade or business at a qualified business site within the governing body's jurisdiction, located outside of an enterprise zone and at least thirty-five percent (35%) of the business' new employees will be residents of an enterprise zone or economically disadvantaged individuals; and
- b) There has been and will continue to be a high level of cooperation between public, private, and neighborhood entities in the area; and
- c) The designation of the Lubrizol Company as an enterprise project is expected to contribute to the achievement of the plans of the City for development and revitalization of the area.

Section 6. The enterprise project shall take effect on the date of designation of the enterprise project by EDT and terminate on December 1, 2014.

Section 7. This ordinance shall take effect from and after its passage as the law and charter in such case provides.

Section 8. It is hereby officially found and determined that the meeting at which this Ordinance was adopted was open to the public, and that public notice of the time, place and purpose of said meeting was given, all as required by Chapter 551 of the Government Code of the State of Texas.

Consideration of and action on an ordinance amending the Fiscal Year 2017-2018 Water & Sewer Fund Budget.

Summary:

It has become necessary to replace and upsize 210 linear feet of waterline located on 2nd Street (between Ivy Street and the Wastewater Treatment Plant) to help with fire safety and water pressure issues at the Wastewater Treatment Plant. The City will be requesting approval to purchase these rehabilitation services from SKE, Inc., through the Buy Board Cooperative Purchasing Program at a cost of \$142,768.49. A budget amendment is needed to cover the cost of this waterline rehabilitation.

Fiscal/Budgetary Impact:

Increase the Fiscal Year 2017-2018 Water & Sewer Fund Budget by \$142,770.00 (Account 40-501-4912, Water Mains), with funding of \$12,365.00 from the remaining available funds in the contingency line item and funding of \$130,405.00 from the prior year revenue in the Water & Sewer Fund, which is available for this purpose.

Approve the ordinance amending the Fiscal Year 2017-2018 Water & Sewer Fund Budget.

AN ORDINANCE AMENDING THE 2017-2018 BUDGET FOR THE CITY OF DEER PARK, TEXAS, AND APPROPRIATING THE SUMS SET UP THEREIN TO THE OBJECTS AND PURPOSES THEREIN NAMED; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DEER PARK:

I.

That the City of Deer Park's budget for the fiscal year ending September 30, 2018 was duly prepared and filed with the City Secretary, where it was available for inspection by any taxpayer.

II.

That it has become necessary to replace and upsize 210 linear feet of waterline located on 2nd Street to help with fire safety and water pressure issues at the Wastewater Treatment Plant.

III.

That it is necessary to amend the budget for the fiscal year ending September 30, 2018 to include \$142,770.00 to replace and upsize 210 linear feet of waterline located on 2nd Street to help with fire safety and water pressure issues at the Wastewater Treatment Plant.

IV.

That a portion of the funding for the amendment to the expenses of the adopted Water & Sewer budget for the fiscal year ending September 30, 2018 will include the amount of \$12,365.00 from the Water & Sewer Fund contingency, which is available for this purpose.

V.

That the remaining portion of the funding for the amendment to the expenses of the adopted Water & Sewer budget for the fiscal year ending September 30, 2018 will include the amount of \$130,405.00 from the prior year revenues of the Water & Sewer Fund, which is available for this purpose.

That the regular budget of the City of Deer Park, Texas, for the fiscal year ending September 30, 2018, be, and the same is hereby, in all respects finally approved and amended as so described above and shall be, and is hereby, filed with the City Secretary of said City.

VII.

That the amounts specified are for the purposes named in said budget, and they are hereby appropriated to and for such purposes.

VIII.

That the City Secretary file copies of this Ordinance and of such budget with all public officers as required by the laws of the State of Texas.

IX.

It is hereby officially found and determined that the meeting at which this Ordinance was adopted was open to the public, and that public notice of the time, place and purpose of said meeting was given, all as required by Chapter 551 of the Government Code of the State of Texas.

X.

The City Council finds that this Ordinance relates to the immediate preservation of the public peace, health, safety and welfare, and that approval of a 2017-2018 Budget amendment be adopted at the earliest possible moment to comply with the City Charter and Statutes of the State of Texas, and to provide protection for persons within the City, thereby creating an emergency, for which the Charter requirement providing for the reading of Ordinances on three (3) several days should be dispensed with, and this Ordinance be passed finally on its introduction, and accordingly, such requirement is dispensed with, and this Ordinance shall take effect upon its passage and approval by the Mayor.

Consideration of and action on an ordinance amending the Fiscal Year 2017-2018 Water & Sewer Fund Budget.

Summary:

On December 5, 2017, City Council authorized emergency repairs to a 12-inch sanitary sewer line due to a break under the median on Center Street between 11th and 12th Street. At the time of this authorization, the cost of these emergency repairs was not known. Vaught Services was working on another sanitary sewer project for the City at that time, and the City requested a quote for these emergency repairs. Vaught Services provided a quote of \$68,815.00 for the work to repair about 120' of sanitary sewer line (note: Vaught Services is on the Buy Board). While it was the City's intent to follow-up with a budget amendment once a cost for these emergency repairs was known, that was overlooked. A budget amendment in the amount of \$68,815.00 is needed to cover the cost of the emergency repairs to the 12-inch sanitary sewer line due to a break under the median on Center Street between 11th and 12th Street.

Fiscal/Budgetary Impact:

Increase the Fiscal Year 2017-2018 Water & Sewer Fund Budget by \$68,815.00 (Account 40-501-4410, Sanitary Sewers & Lift Station Maintenance) to be funded by the contingency line item included in the Fiscal Year 2017-2018 Water & Sewer Fund. Contingency funds are available for this purpose.

Approve the ordinance amending the Fiscal Year 2017-2018 Water & Sewer Fund Budget.

ORDINANCE NO.

AN ORDINANCE AMENDING THE 2017-2018 BUDGET FOR THE CITY OF DEER PARK, TEXAS, AND APPROPRIATING THE SUMS SET UP THEREIN TO THE OBJECTS AND PURPOSES THEREIN NAMED; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DEER PARK:

I.

That the City of Deer Park's budget for the fiscal year ending September 30, 2018 was duly prepared and filed with the City Secretary, where it was available for inspection by any taxpayer.

II.

That on December 5, 2017, City Council authorized emergency repairs to a 12-inch sanitary sewer

line due to a break under the median on Center Street between 11th and 12th Street.

III.

That at the time of this authorization for the emergency repairs to the 12-inch sanitary sewer line, the cost of the repairs was unknown.

IV.

That subsequent to this authorization for the emergency repairs to the 12-inch sanitary sewer line, the City received a quote from Vaught Services, a vendor on the Buy Board, who was working on another sanitary sewer project for the City at that time.

V.

That Vaught Services was able to complete the emergency repairs to the 12-inch sanitary sewer line at a cost of \$68,815.00.

VI.

That it is necessary to amend the budget for the fiscal year ending September 30, 2018 to include \$68,815.00 for the emergency repairs to the 12-inch sanitary sewer line.

That funding for the amendment to the expenses of the adopted Water & Sewer budget for the fiscal year ending September 30, 2018 will include the amount of \$68,815.00 from the Water & Sewer Fund contingency, which is available for this purpose.

VIII.

That the regular budget of the City of Deer Park, Texas, for the fiscal year ending September 30, 2018, be, and the same is hereby, in all respects finally approved and amended as so described above and shall be, and is hereby, filed with the City Secretary of said City.

IX.

That the amounts specified are for the purposes named in said budget, and they are hereby appropriated to and for such purposes.

X.

That the City Secretary file copies of this Ordinance and of such budget with all public officers as required by the laws of the State of Texas.

XI.

It is hereby officially found and determined that the meeting at which this Ordinance was adopted was open to the public, and that public notice of the time, place and purpose of said meeting was given, all as required by Chapter 551 of the Government Code of the State of Texas.

ORDINANCE NO.

AN ORDINANCE AMENDING SECTION 66-176, SCHEDULE E, OF THE CODE OF ORDINANCES OF THE CITY OF DEER PARK, TEXAS, PROVIDING FOR AMENDED TRAFFIC REGULATIONS; PROVIDING A SAVINGS CLAUSE; PROVIDING FOR SEVERABILITY; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DEER PARK:

1. The City Council of the City of Deer Park, Texas hereby finds again and now as set forth

in Section 66-176 of the Code of Ordinances of said City, adopted September 15, 2015.

2. That Section 66-176, Schedule E, of the Code of Ordinances of the City of Deer Park, be

amended by replacing the locations for official traffic control devices bearing the words "SPEED LIMIT

3. This Ordinance applies only to offenses committed on or after its effective date, and an action for an offense committed before this Ordinance's effective date is governed by the Ordinance existing before the effective date, which Ordinance is to be continued in effect for this purpose as if this Ordinance were not in force.

Page 1 of 3 Amending Section 66-176 Traffic Regulations 4. If any provision of this Ordinance or the application thereof to any person or circumstances is held invalid, such invalidity shall not affect other provisions or applications of this Ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this Ordinance are declared to be severable.

5. It is officially found and determined that the meeting at which this Ordinance was adopted was open to the public; and that public notice of the time, place and purpose of said meeting was given, all as required by Chapter 551 of the Government Code of the State of Texas.

6. The City Council finds that this Ordinance relates to the immediate preservation of the public peace, safety and welfare, in that it is necessary that the above regulations be immediately put into effect to orderly regulate and guide traffic movement for the protection of persons and property, thereby creating an emergency, for which the Charter requirement providing for the reading of Ordinances on three (3) several days should be dispensed with, and this Ordinance should be passed finally on its introduction, and, accordingly, such requirement is dispensed with, and this Ordinance shall take effect upon its passage and approval by the Mayor.





AN ORDINANCE GRANTING A SPECIFIC USE PERMIT TO SODALIS SENIOR LIVING TO OPERATE A LICENSED MEMORY CARE AND ASSISTED LIVING FACILITY LOCATED AT 2000 EAST BOULEVARD, DEER PARK, HARRIS COUNTY, TEXAS; AND DECLARING AN EMERGENCY.

WHEREAS, CHURCH OF CHRIST DEER PARK, the owner of 2000 East Boulevard, Deer Park, Texas more fully described as being 8.5397 acres of land out of Outlot 586 of the Outlots to the Town of LaPorte, as recorded in Volume 1, Page 33, of the Map Records of Harris County, Texas. Said 8.5397 acres being situated in the Nicholas Clopper Survey, Abstract No. 198, Harris County, Texas and being more particularly described by metes and bounds in attached Exhibit "A", has made application for a Specific Use Permit on behalf of **SODALIS SENIOR LIVING**, pursuant to section 17.04 of Ordinance No. 3886, the Zoning Ordinance Appendix "A" of the City of Deer Park, Texas, to operate a licensed memory care and assisted living facility on said property; and

WHEREAS, following due notice, the Planning and Zoning Commission of the City of Deer Park, Texas, held a Public Hearing upon such application and, having investigated the manner in which the proposed location and character of such Specific Use will affect the Zoning Ordinance and the comprehensive plan of the City of Deer Park, Texas, made final report and recommendation to the City Council of the City of Deer Park, Texas, recommending that such application be conditionally granted; and

WHEREAS, the City Council of the City of Deer Park, Texas, finds that the granting and approval of said application for such Specific Use Permit will not adversely affect the character and appropriate use of the area of neighborhood in which it is proposed to be located, will not substantially depreciate the value of adjacent and nearby properties for use in accordance with the regulations of the Zoning District in which they are located; will not be detrimental in keeping with the spirit and intent of

said Zoning Ordinance; will not adversely affect traffic, public utilities, public health, public safety and the general welfare under the conditions hereinafter set forth;

Said 8.5397 acres being situated in the Nicholas Clopper Survey, Abstract No. 198, Harris County, Texas and being more particularly described by metes and bounds in attached Exhibit "A" subject to **SODALIS SENIOR LIVING'S** complying with all the requirements of the Zoning Ordinance of the City of Deer Park and plat submitted for said project.

2. A copy of this Ordinance, duly certified by the City Secretary and approved by the City Engineer of the City of Deer Park, Texas shall operate as the Permit.

3. It is hereby officially found and determined that the meeting at which this Ordinance was adopted was open to the public, and that public notice of the time, place and purpose of said meeting was give, all as required by Chapter 551 of the Government Code of the State of Texas.

4.
