 - a. Doyle Fletcher, 1918 North Carlsbad, commented, "Thank you all for letting me come up. My wife and I have been there for about 12 years now. We have requested a six (6) foot eight (8) inch variance to the width of our driveway. Our house sits on the end of the block in a cul-de-sac. We have struggled with parking for years, we had to reach out and get post office box. We decided to try to seek approval for a variance to extend our driveway so we can avoid that issue in the future. I did submit a variance letter on October 21, 2018, where I addressed the request. I wanted to point out that we have AR Construction, Art Rodriguez, as our contractor which is on your approved list. Hopefully, we will get approved so Art can go to work."

Commissioner Balusek asked, "Are you just extending the width of the driveway to the street?"

Mr. Fletcher responded, "Yes."

Commissioner Cox asked, "It does not look like there is a radius drawn in. Will you be providing a radius?"

Mr. Fletcher responded, "Absolutely. My understanding was that there is supposed to be an inspector that was going to come out and give us some guidance. I have talked to Art and we have addressed it. We are a foot over our property line. I believe he is in accordance with all the guide lines that are to be addressed. If there are any questions we can certainly have Art address it. I am not an architect, and I did that drawing the best I could, along with the letter. We did get the measurements correct though."


