 - a. Kevin Manuel, 2306 Peyton Place, commented, "We are requesting to remodel our garage to house a motor home. It requires a 14 foot garage door, which is the reason for the primary variance of 7 feet. The structure will be made out of hardy plank and have a composite asphalt shingled roof. There will not be any metal anywhere. We will have a couple of windows in the design but the windows will be on the first floor lower level. There will not be any windows up above anyone's backyard."

Commissioner Balusek asked, "Why are you wanting 22 feet in height?"

Mr. Manuel responded, "The garage door is 14 feet and it requires another 7 feet to match the house aesthetically just like the existing structure we have right now. We have a 7 foot door and the garage peek is 15 feet."

Commissioner Cox asked, "You mentioned hardy siding, what is there now on the existing house?"
