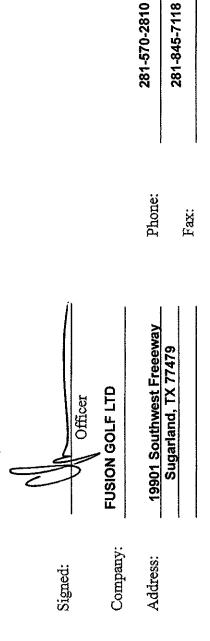

- 3. <u>DISCUSSION AND ACCEPTANCE OF PRESENTATION OF PRELIMINARY ARCHITECTURE DESIGNS AND COST ANALYSIS BY PGAL FOR A NEW EMERGENCY OPERATIONS CENTER (EOC) AT THE DEER PARK POLICE DEPARTMENT STATION City Engineer Adam Ballesteros introduced PGAL Architect Paul Bonnette who gave a</u>

presentation of the overview and results of the assessment for updating the existing Police Station. This presentation included descriptions of the overall conceptual design, Emergency Operations Center (EOC) expansion, existing Police Station renovation, existing entry perspective and the conceptual budget estimate. The estimated total cost for the project is \$4,589,105.00. (Exhibit A1- A7)

Councilman Patterson asked, "Why are the Dispatch consoles half the cost of the Motorola consoles? Is it because of the number of consoles?"

Mr. Bonnette responded, "Yes. That is for six (6) new consoles and a heavy duty chair as well."

Police Chief Grigg responded, "The current Motorola radios need to be replaced. We are having to upgrade them at this point."

Councilwoman Garrison commented, "What did you say the soft cost was?"

Mr. Bonnette responded, "Design fees, surveys, testing during construction of concrete and other materials. That is what the soft cost is going to cover."

Mr. Bonnette continued the presentation with detailing other costs that include day to day upkeep and replacement of equipment in the existing facility, jail automated access system, proposed design and the construction schedule. Mr. Bonnette concluded his presentation by advising Council that there should be some very competitive bids for this project and that construction is anticipated to last about 10 months.

Councilwoman Garrison asked, "Who is going to pay for this?"

Assistant City Manager Gary Jackson responded, "The Crime Control Prevention District budget does have the funds for the construction of the facility and the design cost. The Police Department has been planning for some time for a project like this. This project will span two fiscal years, it is programmed to be finished in the summer of 2022. Once we actually get bids in, we can amend the budget to use the greater portion of the fund balance in this fiscal year or budget for next fiscal year where many of those expenses will hit. There is enough fund balance in Crime Control Prevention budget to do the project."

Councilwoman Garrison asked, "What is the number that has been allotted?"

Mr. Jackson responded, "Right now, there is 3.5 million dollars that was budgeted for actual construction and another quarter of a million dollars for the design costs."

President George Pinder asked, "Are they going to raise the floor in the dispatch area?"

Mr. Bonnette responded, "Yes."

Councilwoman Sinor asked, "What is the square footage that the dispatch is in right now?"

Police Chief Grigg responded, "340 square feet, less than what I thought."

Mayor Mouton commented, "I hope it goes without saying that from my perspective as Mayor, and I know everyone on Council and on the Crime Control District Board support the men and women in blue in Deer Park and we appreciate what you all do. I hope that it is not taken for granted in the day and age that we are living in. We appreciate all that you do and I hope you convey that to the Staff in the department. Thank you for keeping our community safe and what it is, that we all value."

- 1. <u>MEETING CALLED TO ORDER</u> Mayor Mouton called the workshop to order at 7:00 p.m.
- 2. COMMENTS FROM AUDIENCE No comments received.
- 3. PRESENTATION ON THE PROPOSED SHADE CANOPY FOR THE COURTS AND THEATRE BUILDING Parks and Recreation Director Charlie Sandberg advised Council of the damage to the columns in front of the Theater/Courts building. After the damage was investigated, the conclusion was to remove the columns, which has been completed. Two projects remain, to install a canopy and to address a drainage issue. Before the drainage issue can be assessed, the setting of the canopy will need to be determined. If the canopy is to be set on piers in the ground, that may prohibit some of the flow of the drainage. The budget for the canopy project is set at \$125,000. Mr. Sandberg introduced USAShade Senior Regional Manager Jared Angelica who gave a presentation on different designs of a canopy and advised Council of the favorable design that is located at the Smart Financial Center in Sugar Land. This canopy is made of a pre-galvanized steel frame, columns, powder coat finish and the nova shield solid fabric with anti-fade properties. This includes a 10 year warranty against fading. Mr. Angelica advised Council that using fabric versus steel will cost 20% 30% less. A rendering of the canopy was presented to Council.

Councilwoman Garrison asked, "What is the measurement from post to post to the building?"

Mr. Angelica responded, "It extends out 30 feet from the post next to the building and 28 feet wide."

Councilwoman Garrison commented, "With all due respect, I do not like this at all. I am just going to be honest and say, I don't think this goes with the building. I think it takes away from the structure of the building. I am not sure if there is something that can be done to correct that."

Mr. Angelica asked, "What is your biggest concern? Is it the fabric?"

Councilman Martin asked, "When I first saw this, my initial thought was similar. Looks sports covers, like what we have over the stands. I will be honest with you, when you showed the picture of the Smart Financial Center in Sugar Land, it looks much better than what I was anticipating. I do see Councilwoman Garrison's concern though. Is there any type of façade that can be put over the metal part to blend it in more?"

Mr. Angelica responded, "Absolutely. You could go around and clad the columns. You could also do something to match that stone in the front."

Councilwoman Sinor commented, "I think I would really like to see this in person."

Councilman Martin asked, "Is there a way we can get a cad drawing where we can see different angles, which may help. I do like the idea of us going to Sugar Land."

Mr. Angelica responded, "I do have engineering drawings for that building that I can provide you all. I also have a conception plan. I agree with going to Sugar Land to see it in person."

City Manager James Stokes asked, "Is 30 feet too much?"

Councilwoman Garrison responded, "This is very modern and contemporary. The Theater/Courts building is not."

Councilwoman Sinor commented, "This is a beautiful product. We just don't want it to look like a sore thumb."

Mr. Stokes asked, "Can you do renderings of 30 feet and 20 feet?"

Mr. Angelica responded, "Yes, we sure can."

Councilwoman Garrison asked, "How is the drainage going to be resolved?"

Assistant Public Works Director Brent Costlow commented, "It is not necessarily that the piers are the issue, we have to know how that water drains off the canopy. We need to know

the size of the canopy and if the arch is going to need gutters to catch the water to drain down into a pipe system or if we are just going to let it run off. That is why we would need to know the style of canopy for the architectural part. Until you know architecturally what design the canopy is, it's not a question as to how we are going to drain the water, it's more of how are we going to collect the water. That's why we wanted to get an idea of the canopy, so that we can figure out how to drain it. That also affects how it looks."

Councilwoman Garrison asked, "How did the water drain originally?"

Mr. Costlow responded, "It didn't drain correctly. That's the problem."

Councilwoman Garrison asked, "What would happen if you didn't put anything there?"

Mr. Costlow responded, "We would have to totally slip everything away from the building, so we would have to take out all of the sidewalk and build up around it a little bit to bring everything away from the building."

Councilwoman Garrison commented, "If you did all that, you wouldn't have to put a canopy in front of the building."

Mr. Costlow responded, "That is correct, but you would not have any protection for anyone walking in or out the front door."

Councilwoman Garrison commented, "Right now, I wish we could just fix the drainage and the leave the building as is. Unless, you can show me something that would really go with the building."

Mr. Sandberg commented, "The reason we wanted to put a canopy there is for when we do the Christmas program and because we wanted to start doing plays outside. The canopy was to assist with programming purposes as well."

Councilwoman Garrison asked, "Why can't you just do something temporary like a tent?" "I just hate to take away from the building. If we don't need a canopy and you can fix the drainage, then why can't we leave the building as is?"

<u>GRANTING A PIPELINE FRANCHISE TO NUSTAR LOGISTICS FOR A TWELVE INCH (12") PROPANE PIPELINE (FIRST READING)</u> – City Manager James Stokes advised Council of a pipeline franchise agreement with NuStar Logistics that was granted previously in 2014. These waterlines were in a degraded condition and either needed to be rehabilitated due to severe leaks or needed to be upsized for better pressure for the area they serve. This project was part of our ongoing mission to rehabilitate the City's water system to reduce water loss, maintain optimal water pressure, and superb water quality.

The services of SKE Construction LLC through the Buy Board totaling \$672,883.79. Due to unforeseen conflicts at the intersections of Luella/Pasadena Blvd. and Luella/13th St. there was overages on the project for additional 12" pipe, fittings, and concrete paving. The total for the overages is shown in a balancing change order in the amount of \$77,169.25. The project's total cost is \$750,053.04. The project has been completed and is ready for Council acceptance.

Fiscal/Budgetary Impact:

This project was funded out of the Series 2018 Water / Sewer Certificates of Obligation Staff is recommending that council accept completion of the project.

AN ORDINANCE GRANTING NUSTAR LOGISTICS, ITS SUCCESSORS AND ASSIGNS, THE RIGHT, PRIVILEGE AND FRANCHISE TO CONSTRUCT, LAY, MAINTAIN, OPERATE AND USE A PIPELINE IN, UNDER AND ACROSS STREETS, AVENUES, PARKWAYS AND BOULEVARDS IN THE CITY OF DEER PARK, HARRIS COUNTY, TEXAS, FOR THE PURPOSE OF TRANSPORTING REFINED PETROLEUM PRODUCTS; PROVIDING FOR A FEE; PROVIDING AN INDEMNITY CLAUSE; PROVIDING THAT THIS FRANCHISE SHALL NOT BE EXCLUSIVE; RESERVING ALL POWERS OF REGULATION; PROVIDING FOR AND ACCEPTANCE; PROVIDING A SEVERABILITY CLAUSE; PROVIDING A PENALTY BY FINE OF UP TO \$2,000.00 FOR EACH DAY'S VIOLATION.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DEER PARK:

Section 1. Subject to compliance with the terms, conditions and provisions of this Ordinance, the City of Deer Park, Texas, herein called "Grantor", does hereby grant unto **NUSTAR LOGISTICS**, its successors and assigns, herein called "Grantee", the right, privilege and franchise to construct, lay, maintain, operate and use, in, under, across and along any and all of the present and future streets, as described in Grantee's proposal, heretofore filed with the City Secretary, a twelve inch (12") pipeline for the purpose of transporting refined petroleum products.

Section 2. Grantee's facilities shall be so constructed and maintained as not to interfere unreasonably with any existing water line, sanitary sewer line, storm sewer line, telephone line, telegraph line, gas line or any appurtenance to any of the same, or with ordinary travel over the public streets, sidewalks, thoroughfares and ways of Grantor or the flow of water in any gutter or drain. Within the streets or other public ways of the Grantor, the location and route of all facilities heretofore or hereafter placed and constructed and to be placed and constructed by Grantee in the construction and maintenance of its pipeline within the corporate boundaries of Grantor shall be subject to the reasonable and proper regulation, control and direction of the Grantor, or of any official of Grantor to whom such duties have been or may be duly delegated, which regulation and control shall include, but not by way of limitation, the right to require, in the relocation of Grantee's facilities, exclusive of facilities installed for service exclusively to the Grantor, at

Grantee's cost within the present, proposed or future proposed streets, both public and private, and places

whenever such shall be reasonably necessary on account of the installation, relocation, change removal or

addition of Grantor's water, sanitary sewer or storm sewer line or appurtenances or the widening, paving,

repaying, change of grade, relocation or other construction by Grantor within such present, proposed or

future proposed public or private streets, places or ways. The surface of any public road, highway, streets,

lanes, alleys or other public place disturbed by Grantee in erecting, constructing, maintaining, operating,

using, extending, removing, replacing or repairing its pipelines shall be restored immediately after the

completion of the work to as good a condition as before the commencement of the work and maintained to

the satisfaction of the Grantor, or of any official of Grantor to whom such duties have been or may be duly

delegated, for one year from the date the surface of said public road, highway, street, lane, alley or other

public place is broken for such construction, maintenance or removal work. Grantee shall, as soon as

reasonably possible, notify City's Fire and Police Departments of the commencement of any of the aforesaid

work giving its location and extent. No public road, highway, street, lane, alley or other public place shall

be encumbered by construction, maintenance or removal work by Grantee for a longer period than shall be

necessary to execute such work.

Section 3. Grantee agrees to pay an initial fee of Two Thousand Five Hundred Dollars (\$2500.00)

for this franchise and an annual fee thereafter in the sum of Five Hundred Dollars (\$500.00), payable

annually in advance, on or before the anniversary date of the final passage of this Ordinance.

Section 4. Grantee agrees by accepting the franchise, to save the City of Deer Park harmless from

all liability for injury or damage to any person or persons, or property, caused by the construction,

maintenance, operation, repair or removal of any part or all of such pipeline, and to pay to the City of Deer

Park all damages caused to the City by reason of any such matters, including, without limitation thereby, the

cost of repaving any cut in any pavement with materials approved by the City Manager and of repairing all

excavations made by the Grantee in any street, alley, or public place.

NuStar Logistics Pipeline Section 5. Nothing herein contained shall ever be held or considered as conferring upon Grantee

and its successors and assigns any exclusive rights or privileges of any nature whatsoever.

Section 6. The Grantor by the granting of this franchise does not surrender or to any extent lose,

waive, impair or lessen the lawful powers and rights, now or hereafter vested in the Grantor to regulate the

operation of this pipeline, and Grantee by its acceptance of this franchise agrees that all such lawful

regulatory powers and rights as the same may be from time to time vested in the Grantor shall be in full

force and effect and subject to the exercise thereof by the Grantor at any time and from time to time. In

granting this franchise, it is understood that the lawful power vested by law in the Grantor to regulate all

public utilities within Grantor and to regulate the local rates of public utilities within the Grantor within the

limits of the Constitution and laws, and to require all persons or corporations to discharge the duties and

undertakings, for the performance of which this franchise is made, is reserved; and this grant is made

subject to all lawful rights, powers and authorities, either of regulation or otherwise, reserved to the Grantor

by law.

Section 7. The terms and conditions hereof shall be equally binding upon the successors and

assigns of Grantee and upon any person or firm or company which may succeed to or acquire the properties

of Grantee within Grantor City. The continued operation of Grantee's pipeline shall be deemed agreement

to all of the terms hereof.

Section 8. City shall have the right to inspect any part of Grantee's pipeline or facilities within

Grantor City at any reasonable time and from time to time.

Section 9. The Grantee shall, within thirty (30) days from the date this Ordinance is finally passed,

file with the Grantor a written statement signed in its name and behalf in the following form:

"The Grantee, for itself, its successors and assigns, hereby accepts the above and foregoing

This Agreement is made and entered into in Deer Park, Harris County, Texas on:

January 19, 2021, by and between

The City of Deer Park, a Municipal Corporation in the State of Texas

AND

Cobb Fendley and Associates. (Cobb Fendley) ENGINEER(s) duly licensed, and practicing under the laws of the State of Texas.

Said Agreement being executed by the City pursuant to the City Charter, Ordinances, and Resolutions of the City Council, and by the Engineer for engineering services hereinafter set forth in connection with the above-designated Project for the City of Deer Park.

DEER PARK retains Cobb Fendley to perform professional engineering services related to:

Proposal for Professional Engineering Services for Drainage Improvements for Norwood Street (Proposal dated: June 02, 2020, and attached hereto as: Exhibit A)

in return for consideration to be paid by DEER PARK under terms and conditions set forth below.

ARTICLE 1. SCOPE OF WORK

- 1.1 ENGINEER will provide engineering, design, consultation, project management, and other services as required to perform and complete the Scope of Work & Services specifically identified in **Exhibit A** of this Agreement. The Services Scope of Work (the "Work") and the time schedules set forth in **Exhibit A** are based on information provided by DEER PARK and ENGINEER. The schedule of milestones and deliverables are essential terms of this Agreement.
- 1.2 If this information is incomplete or inaccurate, or if site conditions are encountered which materially vary from those indicated by DEER PARK, or if DEER PARK directs ENGINEER to change the original Scope of Work shown in Attachment A, a written amendment equitably adjusting the costs, performance time and/or terms and conditions, shall be executed by DEER PARK and ENGINEER.

ARTICLE 2. COMPENSATION

- 2.1 ENGINEER bills for its services on a time and materials basis using the Schedule of Rates and Terms entitled Estimated Level of Effort ("Schedule of Rates") attached as Exhibit A of this Agreement. As requested, ENGINEER has provided an estimate of the fees for the Work amounting \$68,720.00 (sixty-eight thousand, seven-hundred and twenty dollars). ENGINEER will not exceed that estimate without prior approval from DEER PARK. ENGINEER will notify DEER PARK, for approval, of any proposed revisions to the Schedule of Rates and effective date thereof which shall not be less than thirty (30) days after such notice.
- 2.2 ENGINEER will submit monthly invoices for Services rendered, and DEER PARK will make payment within thirty (30) days of receipt of ENGINEER'S invoices. If DEER PARK objects to all or any portion of an invoice, it will notify ENGINEER of the same within fifteen (15) days from the date of receipt of the invoice and will pay that portion of the invoice not in dispute, and the parties shall immediately make every effort to settle the disputed portion of the invoice. Prices or rates quoted do not include state or local taxes.

ARTICLE 3. DEER PARK'S RESPONSIBILITIES

- 3.1 DEER PARK will designate in writing the person or persons with authority to act on DEER PARK's behalf on all matters concerning the work to be performed.
- 3.2 DEER PARK will furnish to ENGINEER all existing studies, reports, data and other information available to DEER PARK necessary for performance of the Work, authorize ENGINEER to obtain additional data as required, and furnish the services of others where necessary for the performance of the Work. ENGINEER will be entitled to use and rely upon all such information and services.
- 3.3 Where necessary to performance of the Work, DEER PARK shall arrange for ENGINEER to have access to any site or property.

ARTICLE 4. PERFORMANCE OF SERVICE

- 4.1 ENGINEER's services will be performed within the schedule and time period set forth in Schedule A.
- 4.2 ENGINEER shall perform the Work, and any additional services as may be required, for the development of the Project to completion.
- 4.3 If required, additional services will be performed and completed within the time period agreed to in writing by the parties at the time such services are authorized.

4.4 If any time period within or date by which any of ENGINEER's services are to be performed is exceeded for reasons outside of ENGINEER's reasonable control, all rates, measures and amounts of compensation and the time for completion of performance shall be subject to equitable adjustment.

ARTICLE 5. CONFIDENTIALITY

5.1 ENGINEER will hold confidential all information obtained from DEER PARK, not previously known by ENGINEER or in the public domain.

ARTICLE 6. STANDARD OF CARE & WARRANTY

- 6.1 Standard of Care. In performing services, ENGINEER agrees to exercise professional judgment, made on the basis of the information available to ENGINEER, and to perform its engineering services with the professional skill and care of competent design professionals practicing in the same or similar locale and under the same or similar circumstances and professional license. ENGINEER also agrees to perform its engineering services as expeditiously as is prudent considering this standard of care. This standard of care shall be judged as of the time and place the services are rendered, and not according to later standards.
- Warranty. If any failure to meet the foregoing standard of care Warranty appears during one year from the date of completion of the service and ENGINEER is promptly notified thereof in writing, ENGINEER will at its expense re-perform the nonconforming work.
- 6.3 The foregoing Warranty is the sole and express warranty obligation of ENGINEER and is provided in lieu of all other warranties, whether written, oral, implied or statutory, including any warranty of merchantability. Engineer does not warrant any products or services of others. ENGINEER, however, expressly acknowledges that these warranty obligations do not eliminate the applicability of the standard of care to all of its work and that the OWNER may still retain remedies against ENGINEER following the expiration of the warranty period in contract, tort, or otherwise as the law allows.

ARTICLE 7. INSURANCE

- 7.1 ENGINEER will procure and maintain insurance as required by law. At a minimum, ENGINEER will have the following coverage:
 - (1) Workers compensation and occupational disease insurance in statutory amounts.
 - (2) Employer's liability insurance in the amount of \$1,000,000.

- (3) Automobile liability in the amount of \$1,000,000.
- (4) Commercial General Liability insurance for bodily injury, death or loss of or damage to property of third persons in the amount of \$1,000,000 per occurrence, \$2,000,000 in the aggregate.
- (5) Professional errors and omissions insurance in the amount of \$1,000,000.
- 7.2 ENGINEER has provided a Statement of Insurance to DEER PARK demonstrating and reflecting that ENGINEER has procured and maintains insurance coverage in accordance with the requirements stated above. That Statement of Insurance is Attachment C of this Agreement.

ARTICLE 8. INDEMNITY

8.1 THE ENGINEER SHALL INDEMNIFY AND HOLD HARMLESS THE CITY, ITS OFFICERS, OFFICIALS, AGENTS AND EMPLOYEES FROM AND AGAINST ALL CLAIMS, CAUSES OF ACTION, LOSSES, LAWSUITS, JUDGMENTS, FINES, PENALTIES, COSTS, DAMAGES, OR LIABILITY OF ANY CHARACTER, TYPE OR DESCRIPTION INCLUDING WITHOUT LIMITATION, ALL EXPENSES OF LITIGATION, INCLUDING EXPERT OR CONSULTANT FEES, COURT COSTS, AND ATTORNEY'S FEES, RESULTING FROM PERSONAL INJURY (INCLUDING DEATH), PROPERTY DAMAGE OR OTHER HARM, BUT ONLY TO THE EXTENT THAT SUCH PERSONAL INJURY, PROPERTY DAMAGE OR HARM IS CAUSED BY OR RESULTS FROM AN ACT OF NEGLIGENCE, INTENTIONAL TORT, INTELLECTUAL PROPERTY INFRINGEMENT, OR FAILURE TO PAY A SUBCONTRACTOR OR SUPPLIER COMMITTED BY THE ENGINEER OR THE ENGINEER'S AGENT, CONSULTANT UNDER CONTRACT, OR ANOTHER ENTITY OVER WHICH THE ENGINEER EXERCISES CONTROL.

IF THE CITY DEFENDS AN ACTION, CLAIM, AND LAWSUIT OR OTHERWISE INCURS ATTORNEY'S FEES AS A RESULT OF AN INDENMIFIED CLAIM AS STATED ABOVE, ENGINEER AGREES TO REIMBURSE THE CITY IN PROPORTION TO THE ENGINEERS LAIBILITY.

8.2 ENGINEER agrees to and shall contractually require its consultants and subcontractors of any tier to assume the same indemnification obligations to Indemnities as stated herein.

ARTICLE 9. OWNERSHIP OF DOCUMENTS

9.1 As long as DEER PARK is current in the payment of all undisputed invoices, all work product prepared by the ENGINEER pursuant to this Agreement, including, but not limited to, all Contract Documents, Plans and Specifications and any computer aided design, shall be the sole and exclusive property of DEER PARK, subject to the ENGINEER's reserved rights.

9.2 ENGINEER's technology, including without limitation customary techniques and details, skill, processes, knowledge, and computer software developed or acquired by ENGINEER or its Consultants to prepare and manipulate the data which comprises the instruments of services shall all be and remain the property of the ENGINEER.

ARTICLE 10. INDEPENDENT CONTRACTOR

10.1 The ENGINEER is an independent contractor and shall not be regarded as an employee or agent of the DEER PARK.

ARTICLE 11. COMPLIANCE WITH FEDERAL, STATE AND LOCAL LAWS

11.1 The ENGINEER shall observe all applicable provisions of the federal, state and local laws and regulations, including those relating to equal opportunity employment.

ARTICLE 12. SAFETY

- 12.1 DEER PARK shall inform the ENGINEER and its employees of any applicable site safety procedures and regulations known to DEER PARK as well as any special safety concerns or dangerous conditions at the site. The ENGINEER and its employees will be obligated to adhere to such procedures and regulations once notice has been given.
- 12.2 ENGINEER shall not have any responsibility for overall job safety at the site. If in ENGINEER's opinion, its field personnel are unable to access required locations or perform required services in conformance with applicable safety standards, ENGINEER may immediately suspend performance until such safety standards can be attained. If within a reasonable time site operations or conditions are not brought into compliance with such safety standards, ENGINEER may in its discretion terminate its performance, in which event, DEER PARK shall pay for services and termination expenses as provided in Article 18.

ARTICLE 13. LITIGATION

- 13.1 At the request of DEER PARK, ENGINEER agrees to provide testimony and other evidence in any litigation, hearings or proceedings to which DEER PARK is or becomes a party in connection with the work performed under this Agreement, unless DEER PARK and the ENGINEER are adverse to one-another in any such litigation.
- 13.2 Any litigation arising out of this Agreement between DEER PARK and ENGINEER shall be heard by the state district courts of Harris County.

ARTICLE 14. NOTICE

14.1 All notices to either party by the other shall be deemed to have been sufficiently given when made in writing and delivered in person, by electronic mail, facsimile, certified mail or courier to the address of the respective party or to such other address as such party may designate.

ARTICLE 15. TERMINATION

15.1 The performance of work may be terminated or suspended by DEER PARK, for any reason. Such suspension or termination shall be subject to notice of DEER PARK's election to either suspend or terminate the Agreement fifteen (15) days' prior to the effective suspension or termination date. The Notice shall specify the extent to which performance of work is suspended or terminated and the date upon which such action shall become effective. In the event work is terminated or suspended by DEER PARK prior to the completion of services contemplated hereunder, ENGINEER shall be paid for (i) the services rendered to the date of termination or suspension and reasonable services provided to effectuate a professional and timely project termination or suspension.

ARTICLE 16. SEVERABILITY

16.1 If any term, covenant, condition or provision of this Agreement is found by a court of competent jurisdiction to be invalid, void or unenforceable, the remainder of this Agreement shall remain in full force and effect, and shall in no way be affected, impaired or invalidated thereby.

ARTICLE 17. WAIVER

17.1 Any waiver by either party or any provision or condition of this Agreement shall not be construed or deemed to be a waiver of a subsequent breach of the same provision or condition, unless such waiver is so expressed in writing and signed by the party to be bound.

ARTICLE 18. GOVERNING LAW

18.1 This Agreement will be governed by and construed and interpreted in accordance with the laws of the State of Texas.

ARTICLE 19. CAPTIONS

19.1 The captions contained herein are intended solely for the convenience of reference and shall not define, limit or affect in any way the provisions, terms and conditions hereof or their interpretation.

ARTICLE 20. ENTIRE AGREEMENT

20.1 This Agreement, its articles, provision, terms, and attached Schedules represent the entire understanding and agreement between DEER PARK and ENGINEER and supersede any and all prior agreements, whether written or oral, and may be amended or modified only by a written amendment signed by both parties.

Project/Limits

Norwood Street Drainage Improvements

The Norwood Street Drainage Improvements project provides for the construction of drainage improvements to alleviate excessive street ponding on Norwood Street. The project area is a small subset of the overall Deer Park Gardens Neighborhood Drainage Project which has previously been studied. This project will include updating the existing drainage models for the project area, determining drainage impacts and creating a mitigated solution. It is anticipated that the project will consist of replacing inlets on Norwood Street and upsizing storm sewer on 8th Street and Norwood Street. The project may also include adding additional inlets to capture overland sheet flow occurring from offsite properties.

Surveying

Drainage Analysis Services

The purpose of performing a hydrologic and hydraulic analysis is to determine if any negative impacts will occur to water surface elevations associated with improving the storm sewer and inlets near the intersection of Norwood Street and E. 8th Street in Deer Park, Texas. The storm sewer improvements associated with this analysis are a small subset of the overall Deer Park Gardens Neighborhood Drainage Project. It has become necessary to perform these improvements to alleviate repetitive street ponding during the more frequent rainfall events.

The following tasks will be performed and the recommended improvements will be described in a letter report and included in the associated plan set:

- 1. Modify the previously prepared existing condition to include the improvements recommended for the project location from the overall neighborhood drainage study

Exclusions for the Scope of Services:

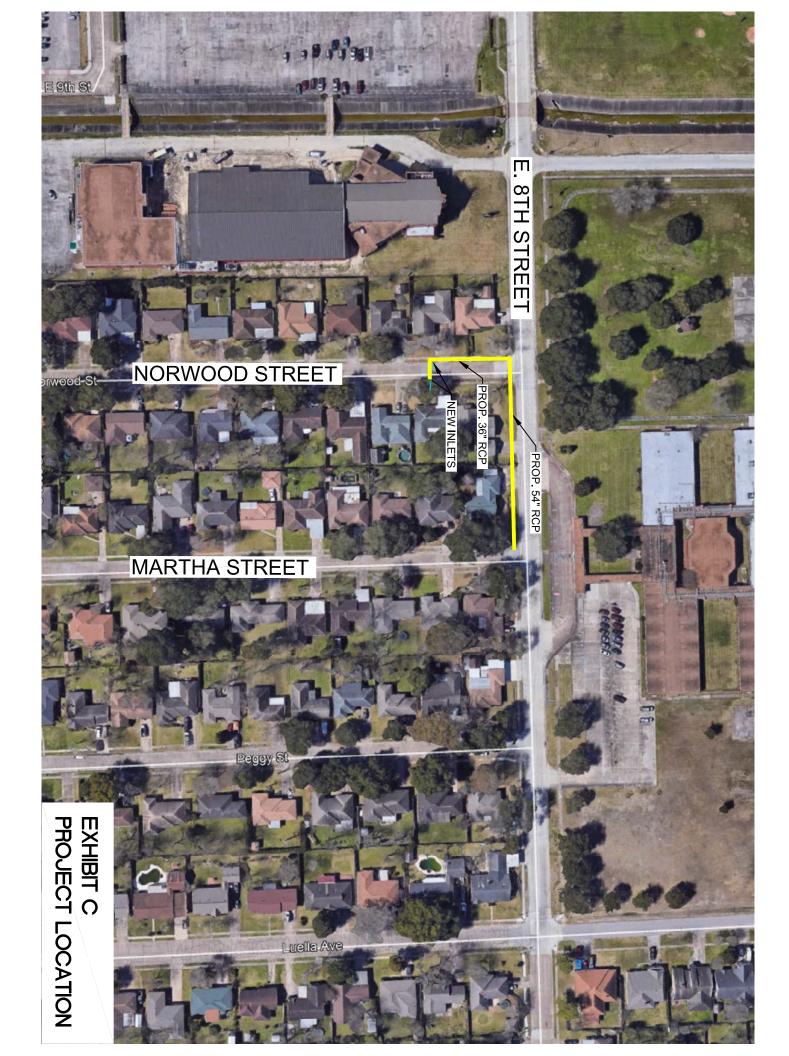

ADDITIONAL SERVICES

The Compensation to be paid to CobbFendley for providing any ADDITIONAL SERVICES under this agreement shall be based on the rate schedule included in the Agreement. Reimbursable items and subconsultant invoices will be subject to a 10% administration charge. Services will be charged according to those personnel directly involved in providing the service, and will be rounded to the nearest half hour.

Lump sum fees will be negotiated for particular, defined assignments at the request of the City. When an occasion arises which the City desires to be covered by a lump sum fee, CobbFendley will negotiate an acceptable fee with the City and prepare an addendum to this Agreement which describes the scope of services to be provided and the fee. The addendum will be effective only after its signature by both parties.

Direct Personnel Expense means salaries and wages paid to CobbFendley's employees plus payroll related costs and benefits such as payroll taxes, worker's compensation, health and retirement benefits, bonuses, sick leave, vacation, and holiday pay applicable hereto.
