AN ORDINANCE AMENDING THE 2021-2022 BUDGET FOR THE CITY OF DEER PARK, TEXAS, AND APPROPRIATING THE SUMS SET UP THEREIN TO THE OBJECTS AND PURPOSES THEREIN NAMED.

OSES THEREIN NAMED.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DEER PARK:

I.

That the City of Deer Park's budget for the fiscal year ending September 30, 2022 was duly prepared and filed with the City Secretary, where it was available for inspection by any taxpayer.

II.

That subsequent to approval of the budget for the fiscal year ending September 30, 2022, it was determined that the East Meadows Detention Pond is overgrown and needs to be cleared of overgrowth in order to maintain positive drainage performance.

III.

That at the regular meeting of City Council on October 19, 2021, the City Council approved the solicitation of bids to clear the overgrowth of the East Meadows Detention Pond in order to maintain positive drainage performance.

IV.

That JBM Landscape & Irrigation, LLC provided the low bid of \$57,155.00 to clear the overgrowth of the East Meadows Detention Pond in order to maintain positive drainage performance.

V.

That it is necessary to amend the Storm Water Fund budget for the fiscal year ending September 30, 2022 to include monies to clear the overgrowth of the East Meadows Detention Pond in order to maintain positive drainage performance.

VI.

That it is necessary to appropriate an additional \$57,155.00 to clear the overgrowth of the East Meadows Detention Pond in order to maintain positive drainage performance.

VII.

That funding for the amendment to the expenditures of the adopted budget for the Storm Water Fund for the fiscal year ending September 30, 2022 will include the additional amount of \$57,155.00 from the prior year revenue of the Storm Water Fund, which is available for this purpose.

VIII.

That the regular budget of the City of Deer Park, Texas, for the fiscal year ending September 30, 2022, be, and the same is hereby, in all respects finally approved and amended as so described and shall be, and is hereby, filed with the City Secretary of said City.

IX.

That the amounts specified are for the purposes named in said budget, and they are hereby appropriated to and for such purposes.

X.

That the City Secretary file copies of this Ordinance and of such budget with all public officers as required by the laws of the State of Texas.

XI.

It is hereby officially found and determined that the meeting at which this Ordinance was adopted was open to the public, and that public notice of the time, place and purpose of said meeting was given, all as required by Chapter 551 of the Government Code of the State of Texas.
