- (1) The center must have an approved written plan to ensure the safety of the children on the playground.
- (2) The playground area must be maintained in accordance to licensing standards (Division 1, Minimum Safety Requirements, 746.4601-746.4609 and Division 5, Surfacing, 746.401-746.4913). The playground must be inspected prior to each class use. Maintenance/safety concerns must be noted and communicated to the Parks Dept. If maintenance is needed, only the grassy area is to be used.


