- 1. MEETING CALLED TO ORDER Mayor Mouton called the meeting to order at 7:30 p.m.
- 2. INVOCATION The invocation was given by Councilman Patterson.
- 3. <u>PLEDGE OF ALLEGIANCE</u> Councilman Martin led the Pledge of Allegiance to the United States Flag and the Texas Flag.
- 4. <u>PRESENTATION OF THE ART PARK PLAYERS CHICAGO PRODUCTION</u> Theater Supervisor, Susan Melee, thanked the Council and the Mayor along with City Manager Jay Stokes and Assistant Gary Jackson, for the opportunity to present the performers from the Chicago Production, performing the song, All That Jazz.

5. JOINT PUBLIC HEARING ON THE REQUEST OF THE CITY OF DEER PARK TO AMEND THE CODE OF ORDINANCES APPENDIX A-ZONING, SECTION 14.02 TO ALLOW HELIPORTS OR HELISTOPS AS AN ACCESSORY USE FOR MEDICAL FACILITIES IN THE HIGHWAY ZONING DISTRICT AND Y AMENDING SECTION 10.3 ZONING MATRIX BY ADDING "S" TO HIGHWAY ZONING DISTRICTS FOR HELISTOPS AND REQUIRING A SPECIFIC USE PERMIT – Public Hearing was opened by City Secretary reading the Notice of Public Hearing. (Exhibit A)

Mayor Mouton opened the hearing on behalf of the City Council.

Chairman Wendeburg opened the hearing on behalf of the Planning and Zoning Commission.

Mayor Mouton called for those persons desiring to speak in favor of the request.

a. Randy Stockwell, "I have been to Planning and Zoning for this and to City Council and it has been discussed for a number of months. The ordinances did not allow for a heliport which we are planning to build on East Boulevard, north of 13th Street, right by the soccer fields. We have been going through the process to get the heliports approved for our use at the facility and the City's use. If there is an accident, life flights can land right there free of charge. The industries will also be able to use it."

Mayor Mouton called for those desiring to speak against the request. No one spoke.

The hearing was closed by Mayor Mouton on behalf of the City Council and Chairman Wendeburg on behalf of the Planning and Zoning Commission.

Motion carried 6 to 0.

CONSIDERATION OF AN ACTION ON A REFERRAL TO THE PLANNING AND ZONING COMMISSION FOR A SPECIFIC USE PERMIT FROM THE REQUEST OF HEALING MINISTRIES OF THE LORD JESUS CHRIST TO OPERATE A CHURCH AT 5014 LUELLA AVENUE Motion was made by Councilman Martin and seconded by Councilman Patterson to refer the request of the Healing Ministries of the Lord Jesus Christ to the Planning and Zoning Commission for a Specific Use Permit request to operate a church at 5014 Luella Avenue. Motion carried 6 to 0.
- 9. CONSIDERATION OF AND ACTION ON THE APPROVAL OF THE CHANGE ORDERS OF THE MAXWELL ADULT CENTER Motion was made by Councilman Ginn and seconded by Councilman Patterson to approve the Change Order of the Maxwell Adult Center. Motion carried 6 to 0.
- 10. CONSIDERATION OF AND ACTION ON ACCEPTING THE AMENDMENT FOR ADDITIONAL PROFESSIONAL SERVICES FROM HALFF AND ASSOCIATES UTILIZING THE SUBCONTRACTOR BRINKLEY SARGENT WIGINTON ARCHITECTS—Motion was made by Councilman Martin and seconded by Councilwoman Sinor to accept the amendment for the additional professional services from Halff and Associates utilizing the subcontractor Brinkley Sargent Wiginton Architects. Motion carried 6 to 0.

Patterson and seconded by Councilwoman Sinor to approve the purchase from Vaught Services LLC, through the TIPS System, to perform sanitary rehabilitation of Deer Meadows Section 3, Greenway Plaza and Meadows Village Subdivisions. Motion carried 6 to 0.

CONSIDERATION OF AND ACTION ON THE PURCHASE OF BLEACHERS FROM GT GRANDSTANDS VIA BUY BOARD FOR GIRLS SOFTBALL RENOVATIONS TYPE B PROJECTS Motion was made by Councilman Harrison and seconded by Councilman Ginn to approve the purchase of bleachers from GT Grandstands for the Girls Softball Renovations Type B Project. Motion carried 6 to 0.
- 14. Councilwoman Sinor asked, "Are these new groups for these last two items?"

Assistant City Manager, Gary Jackson responded, "Yes, these are new groups. We belong to about 15 - 17 different groups. The chairs are being purchased from the previous cooperative group and the slide for the Parks and Recreation pool is from this cooperative group."

Motion carried 6 to 0.

16. AWARDING BID FOR A FIBERGLASS WATERSLIDE SYSTEM AT THE DOW PARK SWIMMING POOL – Motion was made by Councilwoman Sinor and seconded by Councilman Patterson to award the fiberglass waterslide system to Vortex USA in the amount of \$125,762.70. Motion carried 6 to 0.
