# 6. COMMENTS FROM AUDIENCE –

a. Jacob Guerra, 905 Dutch, Deer Park commented, "I am currently the President of Deer Park Pony Baseball. I wanted to first apologize that it has taken me so long. I intended to get in here right after baseball season but baseball season rolled into football season which rolled into fall ball baseball season which now we only have about a two week break before with Thanksgiving holidays and back into baseball.
