

ORDINANCE NO. _____

AN ORDINANCE AMENDING THE 2018-2019 BUDGET FOR THE CITY OF DEER PARK, TEXAS, AND APPROPRIATING THE SUMS SET UP THEREIN TO THE OBJECTS AND PURPOSES THEREIN NAMED; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DEER PARK:

I.

That the City of Deer Park's budget for the fiscal year ending September 30, 2019 was duly prepared and filed with the City Secretary, where it was available for inspection by any taxpayer.

II.

That in November 2018, the Library received notification that the City had been awarded a reimbursement grant in the amount of \$5,200.00 based on the City's Interlibrary Loan Program.

III.

That in 2019, the Library is celebrating its 50th Anniversary and as part of the planned refresh to celebrate this milestone would like to apply these additional grant funds to the overall refresh of the Library by purchasing new shelving and furniture to enhance operations.

IV.

That following the recent change from the Dewey Decimal System, the purchase and relocation of shelves within the Library would accommodate the addition of genre shelving for more convenient browsing and increased circulation.

V.

That as part of the overall refresh of the Library, the replacement of furniture and chairs that have deteriorated from wear and tear would enhance Library operations and benefit Library patrons.

VI.

That to apply these grant monies toward the refresh of the Library would necessitate amending the budget for the Library for the fiscal year ending September 30, 2019.

VII.

That funding for the amendment to the expenditures of the adopted Library budget for the fiscal year ending September 30, 2019 will include the amount of \$5,200.00 from the unassigned fund balance of the General Fund, which is available for this purpose.

VIII.

That the regular budget of the City of Deer Park, Texas, for the fiscal year ending September 30, 2019, be, and the same is hereby, in all respects finally approved and amended as so described above and shall be, and is hereby, filed with the City Secretary of said City.

IX.

That the amounts specified are for the purposes named in said budget, and they are hereby appropriated to and for such purposes.

X.

That the City Secretary file copies of this Ordinance and of such budget with all public officers as required by the laws of the State of Texas.

XI.

It is hereby officially found and determined that the meeting at which this Ordinance was adopted was open to the public, and that public notice of the time, place and purpose of said meeting was given, all as required by Chapter 551 of the Government Code of the State of Texas.

XII.

The City Council finds that this Ordinance relates to the immediate preservation of the public peace, health, safety and welfare, and that approval of a 2018-2019 Budget amendment be adopted at the earliest possible moment to comply with the City Charter and Statutes of the State of Texas, and to provide protection for persons within the City, thereby creating an emergency, for which the Charter requirement providing for the reading of Ordinances on three (3) several days should be dispensed with, and this

Ordinance be passed finally on its introduction, and accordingly, such requirement is dispensed with, and this Ordinance shall take effect upon its passage and approval by the Mayor.

In accordance with Article VIII, Section 1 of the City Charter, this Ordinance was introduced before the City Council of the City of Deer Park, Texas, **passed, approved and adopted** on this the ____ day of _____, 2019 **by a vote of** _____ **“Ayes” and** _____ **“Noes”**.
