ORDINANCE NO.

AN ORDINANCE AMENDING THE 2018-2019 BUDGET FOR THE CITY OF DEER PARK, TEXAS, AND APPROPRIATING THE SUMS SET UP THEREIN TO THE OBJECTS AND PURPOSES THEREIN NAMED; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DEER PARK:

I.

That the City of Deer Park's budget for the fiscal year ending September 30, 2019 was duly prepared and filed with the City Secretary, where it was available for inspection by any taxpayer.

II.

That the City of Deer Park's Hotel Occupancy Tax Fund budget for the fiscal year ending September 30, 2019 included \$250,000.00 for repairs to the truss of the historic bridge at the Battleground Golf Course.

III.

That the City advertised for bids to complete the repairs to the truss of the historic bridge at the Battleground Golf Course and received only one bid from Gibson & Associates, Inc. in the amount of \$471,950.00.

IV.

That the bid amount of \$471,950.00 to complete the repairs to the truss of the historic bridge at the Battleground Golf Course exceeds the amount budgeted for the project by \$221,950.00.

 \mathbf{V} .

That in order to accept the bid from Gibson & Associates, Inc. in the amount of \$471,950.00, it is necessary to amend the Hotel Occupancy Tax Fund budget for the fiscal year ending September 30, 2019 to include an additional amount of \$221,950.00 to complete the repairs to the truss of the historic bridge at the Battleground Golf Course.

VI.

That the additional expenditure of \$221,950.00 needed to complete the repairs to the truss of the historic bridge at the Battleground Golf Course would be funded out of the prior year revenue of the Hotel

Occupancy Tax Fund, which is available for this purpose.

VII.

That the amounts specified are for the purposes named in said budget, and they are hereby

appropriated to and for such purposes.

VIII.

That the regular budget of the City of Deer Park, Texas, for the fiscal year ending September 30,

2019, be, and the same is hereby, in all respects finally approved and amended as so described above and

shall be, and is hereby, filed with the City Secretary of said City.

IX.

That the City Secretary file copies of this Ordinance and of such budget with all public officers as

required by the laws of the State of Texas.

X.

It is hereby officially found and determined that the meeting at which this Ordinance was adopted

was open to the public, and that public notice of the time, place and purpose of said meeting was given,

all as required by Chapter 551 of the Government Code of the State of Texas.

XI.

The City Council finds that this Ordinance relates to the immediate preservation of the public peace,

health, safety and welfare, and that approval of a 2018-2019 Budget amendment be adopted at the earliest

possible moment to comply with the City Charter and Statutes of the State of Texas, and to provide

protection for persons within the City, thereby creating an emergency, for which the Charter requirement
