ORDINANCE NO.

AN ORDINANCE AMENDING THE 2017-2018 BUDGET FOR THE CITY OF DEER PARK, TEXAS, AND APPROPRIATING THE SUMS SET UP THEREIN TO THE OBJECTS AND PURPOSES THEREIN NAMED; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DEER PARK:

I.

That the City of Deer Park's budget for the fiscal year ending September 30, 2018 was duly prepared and filed with the City Secretary, where it was available for inspection by any taxpayer.

II.

That the budget for the fiscal year ending September 30, 2018 included technology replacement costs in the budget for IT Services.

III.

That the Fire Marshal was due for a replacement of a desktop but chose to purchase a portable multi-function device to replace that desktop and a laptop computer for more convenient portability and operational efficiency with the single multi-function device.

IV.

That because the new multi-function device represented a new technology request and not replacement technology, the purchase was charged to the Fire Marshal's budget and not the IT Services budget resulting in a net variance for the Fire Marshal's budget for the fiscal year ending September 30, 2018 of approximately \$200.00.

V.

That it is necessary to amend the budget for the fiscal year ending September 30, 2018 to appropriate an additional \$200.00 to fully fund the Fire Marshal's Office expenditures for the fiscal year.

VI.

That funding for the amendment to the expenditures of the adopted budget for the Fire Marshal's

Office will include the amount of \$200.00 from the unassigned fund balance of the General Fund.

VII.

That the regular budget of the City of Deer Park, Texas, for the fiscal year ending September 30,

2018, be, and the same is hereby, in all respects finally approved and amended as so described and shall be,

and is hereby, filed with the City Secretary of said City.

VIII.

That the amounts specified are for the purposes named in said budget, and they are hereby

appropriated to and for such purposes.

IX.

That the City Secretary file copies of this Ordinance and of such budget with all public officers as

required by the laws of the State of Texas.

X.

It is hereby officially found and determined that the meeting at which this Ordinance was adopted

was open to the public, and that public notice of the time, place and purpose of said meeting was given, all

as required by Chapter 551 of the Government Code of the State of Texas.

XI.

The City Council finds that this Ordinance relates to the immediate preservation of the public peace,

health, safety and welfare, and that approval of a 2017-2018 Budget amendment be adopted at the earliest

possible moment to comply with the City Charter and Statutes of the State of Texas, and to provide

protection for persons within the City, thereby creating an emergency, for which the Charter requirement
