Notwithstanding the foregoing, if Assignee elects not to purchase the Property under the Contract, then Assignee shall reassign the Contract to Assignor, all on or before the date for closing, whereupon Assignee shall have no further liability to Assignor. If Assignee closes the purchase of the Property under the Contract, Assignee shall reimburse Assignor for the earnest money and extension fees paid by Assignor prior to the closing.
