- 1. <u>NOTICE OF PUBLIC HEARING</u> The public hearing was opened by the City Secretary reading the Notice of Public Hearing. (Exhibit A)
- HEARING OPENED FOR THOSE PERSONS DESIRING TO SPEAK IN FAVOR OF THE <u>REQUEST</u> – Chairman Balusek opened the public hearing for those persons desiring to speak in favor of the request.

a. George McDaniel, 1818 Karankawas Court, spoke in favor of the request for the variance of nine feet for the separation of driveways for a second driveway. Mr. McDaniel commented, "I have been wanting to fence in the part that I could by the boundaries to have use of it instead of just having an empty side yard. I got a permit to include some of that inside the fence. I would also want to build a driveway to have access to the backyard. Right now, I drive my vehicle on the grass, which I do not prefer to do. I would rather have the driveway. For one, I would like to have access to my backyard and to provide additional parking at my house. Often times, people will park on the side of the road where my house is on the corner. If anyone is parked on my side of the road, it is impossible for them to turn, and it creates an inconvenience. Having a driveway, I will have parking for family when they come to visit.

Chairman Balusek asked, "Is the side lot all the way to X Street yours?"

Mr. McDaniel responded, "Yes."

Chairman Balusek asked, "Can you move the driveway over further?"

Mr. McDaniel responded, "If I move it any further towards X Street, it will be too close to the corner. If I was backing out, there could be a vehicle there at the corner that I may have to confront."

Chairman Balusek asked, "The house on X Street, where is the boundary on that?"

Mr. McDaniel responded, "The house on X Street has a 25 foot building line."

Chairman Balusek asked, "From X Street or from your street?"

Mr. McDaniel responded, "My lot is deeper than 25 foot by their house."

Chairman Balusek asked, "How far is that driveway going to come to that house?"

Mr. McDaniel responded, "It will be a long ways from their house."

Chairman Balusek asked, "Is it just going to go straight or will it turn into the fence?"

Mr. McDaniel responded, "The fence is going to be at an angle, according to the setback line and driveway is going to be perpendicular with the fence. It is going to be a 90 degree angle from the driveway to the fence. If I were to swing it any further toward X Street, it makes the driveway too close to the corner."

Commisioner Garrett asked, "Do you have a contractor doing the work?"

Mr. McDaniel responded, "I am a builder."
