AMENDMENT Texas Emergency Services Retirement System and City of Deer Park, Texas Deer Park Fire Department

The Texas Emergency Services Retirement System (TESRS) and City of Deer Park, Texas (Governing Entity), on behalf of the Deer Park Fire Department (Participating Department), entered into a Contract effective January 1, 1978. The parties agree to the amendment of the Contract as described below. The effective date of this Amendment is October 1, 2020.

Supplemental Payment to Certain Retirees:

Effective October 1, 2020, TESRS and the Governing Entity agree to facilitate the Governing Entity's election to provide a one-time, supplemental payment to Deer Park TESRS retirees as of September 30, 2020, as delineated on Attachment A, Supplemental Payments. Before November 30, 2020, TESRS will make the supplemental payment to the identified retirees in the amount specified for each listed in Attachment A and, in accordance with instructions from TESRS, the Governing Entity will reimburse TESRS the total amount of the supplemental payments made.
