- 1. <u>NOTICE OF PUBLIC HEARING</u> The public hearing was opened by the City Secretary reading the Notice of Public Hearing. (Exhibit A)
- 2. <u>HEARING OPENED FOR THOSE PERSONS DESIRING TO SPEAK IN FAVOR OF THE REQUEST</u> Chairman Balusek opened the hearing for those persons desiring to speak in favor of the request.
  - a. Jeff Robinson of Northwinds Construction spoke on behalf of Tom Bedford and in favor of the rezone for the Bedford Family Trust and highlighted the addition of four buildings totaling 60,000 square feet next to La Quinta Inn on East Boulevard that will allow easy access to Highway 225. Mr. Robinson presented a rendering of the buildings that will aesthetically include metal, glass and stone with heavy landscaping. (Exhibit B1-B5)

Commissioner Tippit asked, "Is this speculative or are there tenants already?"

Mr. Robinson responded, "It's speculative."

Commissioner Wendeburg asked, "What is the timeline?"

Mr. Robinson responded, "I would suspect about three to four months for the permit process and then another six to eight months to complete construction."

Chairman Cox asked, "Would you be constructing all four buildings at the same time?"

Mr. Robinson responded, "No, we would be looking at two buildings at first and the second phase right after that."
