We have put together a list of five projects that are similar to the City of Deer Park Bike & Hike Trail ph.1. Four of these projects are complete. Our project Neuns Rd, is currently still ongoing. I will go into detail on the scope of work, performance, budget adherence, liquidated damages, claims, and key personnel.

Project Name: Generation Park, 2019

Owner: Harris County
Contract Amount: \$385,000
Description of work:

Moran Construction started this project in April 2019, and it was completed in November of 2019. This project consisted of concrete sidewalks (15,000 sf), concrete driveways (10,000 sf), and concrete shared use paths (18,000 sf). This was a new development where SER Construction was doing concrete pavement and underground utilities. We were contracted by SER Construction to complete sidewalks, driveways, and shared use paths. Jose Prieto was the project manager and Leticia Hernandez was the operations manager. We worked together and coordinated with SER and Harris County to ensure the project would be completed on time, safely, and accurately. Jose worked directly with Harris County and design partners to make updates in elevations and designs. The shared use path that we were contracted to pave was 6ft wide and stretched about 3,000 ft. Leticia Hernandez coordinated directly with Harris County and SER to ensure compliance throughout the project. She ensured daily reports, safety reports, certified payroll, and invoicing was processed in a timely manner and accurately. The project required minor modifications to elevations and design of some driveways. Other than that, this project ran very smoothly. We were able to complete the project within 7 months, one month earlier than anticipated. We were able to stay within budget, there were no liquidated damages, nor any claims.

Project Name: Briar Branch, 2019

Owner: City of Houston Contract Amount: \$627,000 Description of work:

Moran Construction started this project in August 2019, and it was completed in September 2020. The project initially include pilot channel, junction boxes, and 10 in. concrete pavement. Moran Construction was able to successfully execute the project. After completing the scope of work, we were contacted to extend our contract to include an 8ft decomposed granite trail, along Briar Branch Creek. The trail was about 4,700 ft long. Jose Prieto managed this project. We completed this phase of the project in three months with a crew of 8 people. We were responsible for implementing a good traffic control system, as we were 2 blocks away from an elementary school. Additionally, we had to work together with Harris County to adjust the original design. Design changes did cause the cost of the project to rise, but we shopped around with our vendors to find the best prices on materials for the trail. By doing this, we were able to adhere to the budget. There were zero liquidated damages and zero claims.

Project Name: Post Oak, 2020 Owner: City of Houston Contract Amount: \$985,000 Description of work:

The scope of work consisted of sidewalks. We had concrete sidewalks, pavers, and decomposed granite sidewalks. Total we had around 200,000 sf of sidewalks. The City of Houston main concern on this project was staying on schedule and being able to keep traffic open, as the Post Oak area is heavy on traffic. We executed an amazing work schedule that allowed us to be the most productive on this project. With the help of our foremen, we were able to maximize production while still ensuring the quality of our work. The project was completed on time, we stayed within budget, there were no liquidated damages, and no claims. Our crews completed the project and mobilized out of the area just in time for the Thanksgiving festival, on Post Oak and San Felipe. We received extra incentives for being able to fully complete the project and mobilize out of the area in time.

Contract Amount: \$1,500,000

Description of work:

Our company began working on this project in January 2020 and we completed the project in October 2020. We 100% completed and mobilized out of the project two and a half months ahead of schedule. The scope of work included concrete paving (157,000 sf), concrete curbs (7,500 lf), concrete driveways (10,400 sf), concrete sidewalks (8,600 sf), and concrete trail (28,401 sf). We had two crews on this project consisting of 10 people per crew, and 2 project managers. We had a day crew and a night crew. Our day crew focused on the driveways, sidewalks, and trails. Our night crew focused on the street paving and curbs. This project did require us to exceed our budget. There were unforeseen changes that needed to be made to the drawings. Jose worked directly with the engineers to minimize the cost of the changes. He also communicated well with our crews to speak about the budget concerns and what everyone needed to do to minimize the additional expenses. Another problem that arose in the project was a crack on a section of concrete that we poured. Jose, city inspectors, and engineers decided that the best course of action would be to remove the concrete and repave it. After a month of investigation Moran Construction was compensated for repaving that part of the street. The concrete provider was held liable for the incurred damages. Again, there were no liquidated damages nor claims on this project.

Contract Amount: \$440,450
Description of work:

Moran Construction began working on this project January 2021. We completed this project in September 2021. This contracted consisted of 5ft sidewalks (22,000 sf) and residential driveways (12,000 sf). The primary focus on this project was to maintain a clean and safe environment as we were working in front of Pine Shadows Elementary and Springwoods Middle School. A side from this, we also had to focus on creating a productive schedule that would allow us to work while minimizing disturbance to drop off and dismissal of both schools. Jose worked diligently with Harris County inspectors and our vendors to ensure that we could pour concrete within specific time ranges. We also
