- 2. <u>HEARING OPENED FOR THOSE PERSONS DESIRING TO SPEAK IN FAVOR OF THE REQUEST</u> Chairman Wendeburg opened the hearing for those persons desiring to speak in favor of the request.
 - a. Cory Driskill, 922 Prince Street, Houston, Texas commented, "We are an industrial development company and we are applying for a Special Use Permit to receive a bulk warehouse designation for our parking requirements of what bulk warehouse requires per the ordinance. We are going to build a Class A investment grade, cross dock distribution building on that site. I believe the site plan was submitted in the package and will be something you will be very pleased with."

Commissioner Balusek asked, "When do you plan to start construction on this?"

Mr. Driskil responded, "We hope to start the middle of March, to the end of March or as soon as we can get out permits."

Commissioner Balusek asked, "How long will it take to build?"

Mr. Driskill responded, "It is about a 7 month process. They can be built pretty quickly. It is a tilt wall construction, mostly built on site."

Commissioner Garrett asked, "There will not be any hazardous material correct?"

Mr. Driskill responded, "I would say that we build these on a speculative basis; we currently don't have a tenant for it. What we do, is comply to whatever the code and ordinances are."

- b. Roger Ponder, 4 North Curlew, La Marque, Texas, commented, "I am a property owner adjacent to the construction they are proposing and I am in favor of allowing the Special Use Permit."
