- 1. MEETING CALLED TO ORDER Mayor Mouton called the meeting to order at 7:30 p.m.
- 2. <u>INVOCATION</u> The invocation was given by Police Chief Greg Grigg.
- 3. <u>PLEDGE OF ALLEGIANCE</u> Councilman Martin led the Pledge of Allegiance to the United States Flag and the Texas Flag.
- 4. JOINT PUBLIC HEARING ON THE REQUEST OF WELLS FARGO BANK TO REZONE 0.4616 ACRES SITUATED IN THE G. PATRICK SURVEY, ABSTRACT 624 LOTS 7 & 8
  AND A PORTION OF AN UNDEVELOPED 30 FOOT PUBLIC ALLEY OUT OF BLOCK 13, SHELL CITY, LOCATED ON THE SOUTH SIDE OF SIXTH STREET, AND 100 FEET EAST OF THE INTERSECTION WITH CENTER STREET FROM A SINGLE FAMILY 2 (SF-2) TO GENERAL COMMERCIAL (GC) Mayor Mouton opened the hearing on behalf

of the City Council. Chairman Tippit opened the hearing on behalf of the Planning and Zoning Commission.

The public hearing was opened by the City Secretary reading the Notice of Public Hearing. (Exhibit A)

Mayor Mouton called for those persons desiring to speak in favor of the request.

a. Lacy Bell of Wells Fargo Bank, commented, "I am here on behalf of the applicant of Wells Fargo Bank. I am here to speak for the rezoning application. I am here if there are any questions."

Mayor Mouton called for those persons desiring to speak against the request.

a. James Sparten, 120 E. 6<sup>th</sup> Street, commented, "I live next door to the Wells Fargo Bank. Last time we were here, I was under the influence that they were going to rezone the property, sell and build a commercial property next to me. I do not want it approved. I have been living on 6<sup>th</sup> Street since 1997. It's always been residential. When you put another building there, it is going to open up everything on the back side of my house to whatever happens. If they're only going to rezone it and the bank keep it, I don't have a problem with that, but if they rezone the property and then sell it where it's commercial zoning. What kind of people are going to go there at different times of the night and everything else? Ever since I have been in the house, I've worked at Rohm Haas. I saw three robberies happen at the bank, people are trying to rip off the ATM machine at night. I don't want the crime scene to come up if it's rezoned general commercial. I don't think it going to help the public out as far as our housing development to resale our property. It's going to bring the value down because no one will want to live next to a commercial property. Thank you."

The hearing was closed by Mayor Mouton on behalf of the City Council and Chairman Tippit on behalf of the Planning and Zoning Commission.

# 7. COMMENTS FROM THE AUDIENCE

a. Sanders Lynn McClure, commented, "I am best friends with this lady here who was a WWII Veteran and a mother of six. I take credit of being the sixth child because I was born in 1956 like her other daughter who is the same age as me. Andy Koeing lives here in Deer Park. We attend the Maxwell Center regularly and I am living with her at her home. I am her caretaker. The great thing about Andy, she loves to fish and about two weeks ago, we were at her ranch beyond the statue of Sam Houston, past Huntsville, you take a left and drive for two hours. I do not know where we were. I have no idea. I am very proud of her. I thank you Mayor for allowing me to give her some recognition. I wish her six kids could stand before you and see the ray of light she has formed. I want to say thank you. Her name is Andy. She attends the Maxwell Center every day. I wanted to let you all know that WWII veterans exist in Deer Park at the age of 96. If there is ever a chance to throw the first pitch out, we were at the Astros game last week and I made my way down to tell them I had someone very special to throw out the first pitch, but Scott from HEB got that privilege. Thank you."

Mayor Mouton commented, "In Deer Park, myself and Council always like to honor those who have served our country. We thank you so much for taking the time out to be here tonight."

PATRICK SURVEY, ABSTRACT NO. 624, LOTS 7-8, TOGETHER WITH A 30 FOOT STRIP BETWEEN LOTS 1-6 AND LOT 7, BLOCK 13, SHELL CITY, CITY OF DEER PARK, HARRIS COUNTY, TEXAS OUT OF THE SINGLE FAMILY-TWO (SF-2) ZONING DISTRICT AND PLACING IT IN THE GENERAL COMMERCIAL (GC) ZONING DISTRICT; PROVIDING FOR SEVERABILITY; PROVIDING PENALTIES BY A FINE UP TO \$2,000.00 FOR EACH DAY'S VIOLATION OF THE PROVISIONS OF SUCH ORDINANCE, AS AMENDED; AND DECLARING AN EMERGENCY.

Commissioner Garrett answered, "No."
