- 1. MEETING CALLED TO ORDER Mayor Mouton called the meeting to order at 7:30 p.m.
- 2. <u>INVOCATION</u> The invocation was given by Councilman Patterson.
- 3. <u>PLEDGE OF ALLEGIANCE</u> Councilman Martin led the Pledge of Allegiance to the United States Flag and the Texas Flag.
- 4. SPECIAL PRESENTATION DEER PARK PONY BASEBALL 8U MAROON ALL STAR TEAM Mayor Mouton recognized the Deer Park Pony Baseball 8U Maroon All Star Team who won the Pony League World Series. Coach Brian Cox introduced the coaches JP Johnson, Jeraco Johnson and Brandon Springer. The players introduced themselves: Cody Hickman, Justin Guerrero, Westyn Pullin, Trey Riddle, Slade Cox, Barrett Springer, Kason Edwards, CJ Cash, and Gavin Johnston.
  - Coach Brian Cox commented, "We appreciate you all for recognizing us. We were able to represent Deer Park and these boys did a fantastic job all summer long representing the City."
- 5. <u>PUBLIC HEARING ON THE CITY'S JUVENILE CURFEW ORDINANCE</u> The public hearing was opened by the City Secretary reading the Notice of Public Hearing. (Exhibit A)

- 8. PRESENTATION OF PROPOSED CITY OF DEER PARK FISCAL YEAR 2018-2019 BUDGET City Manager Jay Stokes presented the budget according to the City Charter and thanked Assistant City Manager Gary Jackson, Finance Director Donna Todd, Purchasing Coordinator Tracy Peterson and the Department Directors for their hard work preparing the budget. Mr. Stokes highlighted budget amounts of each fund with a total budget of \$67.4 million dollars. There are three full-time positions and seven part-time positions being added. There is a 1.8 percent cost of labor increase for all full-time employees based upon the study done earlier this year. In the Water and Sewer Fund, there is a plan to borrow 6.4 million dollars in the 8th year of the 10-year process of issuing debt to repair things in the Water and Sewer Capital Program throughout the City. Mr. Stokes highlighted changes to the budget since the budget meeting. There was \$475,000 added to General fund for projects that were budgeted in the current year that are not going to be finished in time, so those funds are be budgeted into the new fiscal year to finish the projects. Adding another \$104,000 to Chapter 380 reimbursement fund and \$90,000 to renovate the Maxwell Adult Center.
- 9. CONSIDERATION OF AND ACTION ON AN ORDINANCE CALLING A PUBLIC HEARING ON THE PROPOSED CITY OF DEER PARK FISCAL YEAR 2018-2019

  BUDGET After a proposed ordinance was read by caption, motion was made by Councilwoman Garrison and seconded by Councilman Ginn to approve Ordinance No. 3993, captioned as follows:

CONSIDERATION OF AND ACTION ON A RESOLUTION TO APPROVE A WRITTEN POLICY TO ACCEPT PRIMARY DEPOSITORY BANK SERVICES APPLICATIONS FROM FINANCIAL INSTITUTIONS NOT DOING BUSINESS WITHIN THE MUNICIPAL BOUNDARIES OF THE CITY OF DEER PARK After a proposed resolution was read by caption, motion was made by Councilman Martin and seconded by Councilman Patterson to approve Resolution No. 2018-10, captioned as follow:

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF DEER PARK, TEXAS, ADOPTING A POLICY PERMITTING THE CONSIDERATION OF APPLICATIONS FOR PRIMARY DEPOSITORY BANK SERVICES
