- 1. <u>NOTICE OF PRELIMINARY PUBLIC HEARING</u> The Preliminary Public Hearing was opened by the City Secretary reading the Notice of Preliminary Public Hearing. (Exhibit A)
- 2. <u>HEARING OPENED FOR THOSE PERSONS DESIRING TO SPEAK IN FAVOR OF THE</u> <u>REQUEST</u> – Chairman Tippit opened the hearing for those wishing to speak in favor of the request.
  - a. Larry Brotherton, Building Official of Deer Park commented, "The Community Service District was eliminated on the advice of Knudson LP when the existing Zoning Ordinance was rehabilitated and then adopted by Ordinance No. 3886 on March 21, 2017. It has become evident that the Community Service Zoning District is needed and is necessary to make previous Community Service District Zoned properties compatible with the current Zoning Ordinance. "The City Attorney, Jim Fox has advised that the Community Service District be adopted back into the Zoning Ordinance."

Commissioner Balusek asked, "Can you clarify what we are doing?"

Mr. Brotherton responded, "The City of Deer Park is requesting to adopt the Community Service Zoning District into the Deer Park Zoning Ordinance and is required to go through the rezoning process."
