- 1. MEETING CALLED TO ORDER Mayor Mouton called the meeting to order at 7:30 p.m.
- 2. <u>INVOCATION</u> The invocation was given by Councilman Patterson.
- 3. <u>PLEDGE OF ALLEGIANCE</u> Councilman Martin led the Pledge of Allegiance to the United States Flag and led the Texas Flag Pledge.
- 4. <u>RECESS/RECONVENE</u> Mayor Mouton recessed the regular meeting at 7:30 p.m. and reconvened at 7:46 p.m.
- 5. PRESENTATION/RECOGNITION OF LIFE SAVING AWARDS Chief Grigg recognized Officers Miranda Ross and Victoria Molini and Dispatcher Kaitlyn Roark for their actions on December 9, 2018. TCO Roark received a 911 call in reference to an 8-year old girl who was not breathing and had no heartbeat. Officers Ross and Molini were dispatched to the residence, and upon arrival took over emergency care of the patient. Deer Park EMS arrived shortly thereafter and the child was rushed to an awaiting ambulance, where she was then transported to Bayshore Medical Center.

Mayor Mouton commented, "I am grateful to you Chief, bringing forth these kinds of scenarios because I think it is important to remember why we do what we do and that you take the time to acknowledge Staff and the role that they play. I am grateful that we work

hard to support our First Responders in both the Fire Department and Police Department to be able to get reports back that you all are making a difference."

6. <u>AWARDING/REJECTING THE BID RECEIVED FOR THE REPAIR OF THE PRATT TRUSS BRIDGE STRUCTURE AT THE BATTLEGROUND GOLF COURSE</u> – Motion was made by Councilwoman Garrison and seconded by Councilman Harrison to amend the FY 2018-2019 Hotel Occupancy Tax (HOT) budget by \$221,950 and award the \$471,950 bid.

City Manager, Jay Stokes commented, "We do not have to amend the budget."

Councilwoman Garrison asked, "If a motion is made and it fails, can another motion be made?"

Councilman Martin commented, "I believe if a motion is made and we have a discussion before Mayor asks us to vote, another motion can be made but not after we vote."

City Manager, Jay Stokes commented, "I would think the Chair could recognize the second motion."

Motion was made by Councilwoman Garrison and seconded by Councilman Harrison to amend the prior motion and award the bid to Gibson & Associates, Inc. in the amount of \$471,950.

Motion carried 5 to 2 with Councilman Ginn and Councilwoman Sinor in opposition.

Motion carried 7 to 0.
