

1. MEETING CALLED TO ORDER – Chairman Tippit called the meeting to order at 6:28 p.m.
2. INVOCATION – The invocation was given by Commissioner Cox.
3. APPROVAL OF MINUTES – Motion was made by Commissioner Balusek and seconded by Commissioner Garrett to approve the minutes as follows:
 - a. Approval of minutes of regular Board of Adjustment meeting on May 20, 2019.Motion carried 5 to 0.
4. CONSIDERATION OF AND ACTION ON A REQUEST FROM KEVIN MANUEL FOR A SEVEN (7) FOOT VARIANCE TO THE HEIGHT OF A DETACHED GARAGE TO BE CONSTRUCTED AT 2306 PEYTON PLACE – Motion was made by Commissioner Cox and seconded by Commissioner Balusek to schedule a Public Hearing for July 1, 2019 at 6:20 p.m. on a request from Kevin Manuel for a seven (7) foot variance to the height of a detached garage to be constructed at 2306 Peyton Place. Motion carried 5 to 0.
5. CONSIDERATION OF AND ACTION ON A REQUEST FROM PAUL & CRYSTAL TABARES FOR A THREE (3) FOOT SIX (6) INCH VARIANCE TO THE SIDE BUILDING LINE AT 1121 IVY AVENUE TO CONSTRUCT A CARPORT – Motion was made by Commissioner Balusek and seconded by Commissioner Garrett to schedule a Public Hearing for July 1, 2019 at 6:25 p.m. on a request from Paul & Crystal Tabares


for a three (3) foot six (6) inch variance to the side building line at 1121 Ivy Avenue to construct a carport. Motion carried 5 to 0.
