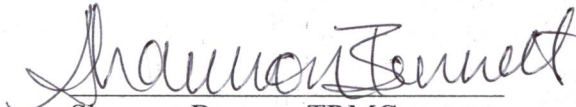
1. MEETING CALLED TO ORDER – Chairman Balusek called the meeting to order at 6:30 p.m.
2. COMMENTS FROM AUDIENCE – No comments received.
3. APPROVAL OF MINUTES – Motion was made by Commissioner Tippit and seconded by Commissioner Cox to approve the minutes as follows:
 - a. Approval of minutes of regular Planning and Zoning meeting on January 20, 2020.

Motion carried 4 to 0.

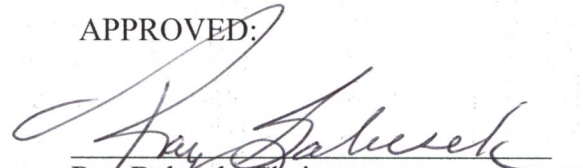
4. CONSIDERATION OF AND ACTION ON APPROVAL OF THE FINAL PLAT FOR THE SHELL FEDERAL CREDIT UNION TRACT ONE – Motion was made by Commissioner Cox and seconded by Commissioner Tippit to approve the final plat for Shell Federal Credit Union Tract One. Motion carried 4 to 0.
5. CONSIDERATION OF AND ACTION ON APPROVAL OF THE FINAL PLAT FOR THE SHELL FEDERAL CREDIT UNION TRACT TWO – Motion was made by Commissioner Wendeburg and seconded by Commissioner Cox to approve the final plat for Shell Federal Credit Union Tract Two. Motion carried 4 to 0.

6. CONSIDERATION OF AND ACTION ON A REQUEST FROM THE WHEELHOUSE, INC. TO REZONE 0.3030 ACRES OF OUTLOT 147 OF THE TOWN OF DEER PARK FROM MULTI-FAMILY 2 (MF-2) TO COMMUNITY SERVICE TO EXPAND THEIR CURRENT FACILITY – Motion was made by Commissioner Cox and seconded by Commissioner Tippit to schedule a public hearing on March 2, 2020 at 6:10 p.m. on the request of The Wheelhouse, Inc. to rezone 0.3030 acres of Outlot 147 of the town of Deer Park from Multi-Family 2 (MF-2) to Community Service to expand their current facility. Motion carried 4 to 0.
7. CONSIDERATION OF AND ACTION ON A REQUEST FROM KIMLEY HORN FOR A PLANNED UNIT DEVELOPMENT (PUD) LOCATED AT 800 W. PASADENA BOULEVARD TO CONSTRUCT A THREE HUNDRED (300) UNIT APARTMENT COMPLEX – Motion was made by Commissioner Wendeburg and seconded by Commissioner Tippit to schedule a public hearing for March 2, 2020 at 6:15 p.m. on the request of Kimley Horn for a Planned Unit Development (PUD) located at 800 W. Pasadena Boulevard to construct a three hundred (300) unit apartment complex. Motion carried 4 to 0.
