1. MEETING CALLED TO ORDER – Mayor Mouton called the meeting to order at 7:30 p.m.
2. INVOCATION – The invocation was given by Councilman Patterson.
3. PLEDGE OF ALLEGIANCE – Councilman Haight led the Pledge of Allegiance to the United States Flag and led the Texas Flag Pledge.
4. COMMENTS FROM THE AUDIENCE – No comments received.
5. CANVASS OF VOTES FOR MAY 1, 2021 CITY GENERAL AND SPECIAL ELECTIONS – Mayor Mouton canvassed the votes of the May 1, 2021 City General and Elections with City Secretary Shannon Bennett.
6. CONSIDERATION OF AND ACTION ON AN ORDINANCE CANVASSING AND DECLARING THE RESULTS OF THE GENERAL ELECTION HELD MAY 1, 2021 – After a proposed ordinance was read by caption, motion was made by Councilwoman Sinor and seconded by Councilman Patterson to adopt on first reading Ordinance No. 4241, captioned as follows:

AN ORDINANCE CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE ELECTION HELD MAY 1, 2021, IN THE CITY OF DEER PARK, TEXAS, FOR MAYOR, COUNCILMEMBER POSITION NO. 1,

COUNCILMEMBER POSITION NO. 2, AND COUNCILMEMBER POSITION
NO. 3.

Motion carried 6 to 0.

7. CONSIDERATION OF AND ACTION ON AN ORDINANCE CANVASSING AND DECLARING THE RESULTS OF A BOND ELECTION HELD ON MAY 1, 2021 – After a proposed ordinance was read by caption, motion was made by Councilman Ginn and seconded by Councilman Haight to adopt on first reading Ordinance No. 4142, captioned as follows:

AN ORDINANCE CANVASSING RETURNS AND DECLARING THE RESULTS OF A BOND ELECTION HELD IN THE CITY OF DEER PARK, TEXAS ON MAY 1, 2021.

Motion carried 6 to 0.

8. CONSIDERATION OF AND ACTION ON AN ORDINANCE CANVASSING AND DECLARING THE RESULTS OF THE TYPE B SPECIAL ELECTION HELD MAY 1, 2021 – After a proposed ordinance was read by caption, motion was made by Councilman Haight and seconded by Councilman Patterson to adopt on first reading Ordinance No. 4143, captioned as follows:

AN ORDINANCE CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE ELECTION HELD MAY 1, 2021, IN THE CITY OF DEER PARK, TEXAS, FOR THE SPECIAL ELECTION REGARDING THE TYPE B SALES AND USE TAX.

Motion carried 6 to 0.

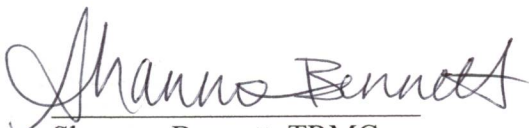
9. PRESENTATION OF CERTIFICATES OF ELECTION – Mayor Mouton presented the Certificates of Election to Councilwoman Sherry Garrison Position 1, Councilman TJ Haight Position 2, and Councilman Tommy Ginn, Position 3.
10. ADMINISTERING THE OATHS OF OFFICE – City Secretary Shannon Bennett administered the Oath of Office to Mayor Jerry Mouton Jr. Mayor Mouton administered the Oath of Office to Councilwoman Sherry Garrison, Position 1, Councilman TJ Haight, Position 2, and Councilman Tommy Ginn, Position 3.
11. RESCIND THE AWARDED OF BID AND REJECTING THE BIDS RECEIVED FOR THE CONSTRUCTION OF THE HIKE AND BIKE TRAIL FROM X STREET TO P STREET AND AUTHORIZATION TO REBID PROJECT – Motion was made by Councilman Patterson and seconded by Councilwoman Garrison to rescind the awarding of the bid for the Hike and Bike Trail from X Street to P Street, to reject all the bids received for the project and authorize to rebid for the Hike and Bike Trail project. Motion carried 6 to 0.

12. CONSENT CALENDAR – Motion was made by Councilman Ginn and seconded by Councilman Haight to approve the consent calendar as follows:

 - e. Authorization to advertise and receive bids on the Surface Water Treatment Plant - Yard Pipe Painting Project.
 - f. Authorization to purchase a replacement irrigation pump system at the Battleground Golf Course.
 - g. Authorization to allow Deer Park High School signage on Center Street from May 22-26, 2021.

Motion carried 6 to 0.

13. CONSIDERATION OF AND ACTION ON RENEWING THE CONTRACT WITH CARUS LLC CORPORATION FOR THE SODIUM HEXAMETAPHOSPHATE FOR THE WATER TREATMENT PLANT – Motion was made by Councilman Ginn and seconded by Councilman Haight to renew the contract with Carus LLC for the Sodium Hexametaphosphate for the Water Treatment Plant. Motion carried 6 to 0.
14. CONSIDERATION OF AND ACTION ON THE PURCHASE OF EMERGENCY EQUIPMENT TO OUTFIT (5) FIVE 2021 CHEVROLET TAHOES (CCPD FUNDED) – Motion was made by Councilwoman Sinor and seconded by Councilman Patterson on the the purchase of equipment to outfit five (5) 2021 Chevrolet Tahoe Pursuit Vehicles. Motion carried 6 to 0.
15. ADJOURN – Mayor Mouton adjourned the meeting at 7:42 p.m.
