CALL TO ORDER - Mayor Mouton called the meeting to order at 7:30 p.m.

INVOCATION - The invocation was given by Councilman Ripley

PLEDGE OF ALLEGIANCE – Councilwoman Ford led the Pledge of Allegiance to the United States Flag and the Texas Flag.

COMMENTS FROM THE AUDIENCE - No comments received by the public.

TAX PAYER IMPACT STATEMENT

House Bill 1522, passed by the 89th Texas Legislature, amends section 551.043 of the Texas Government Code to require that the notice of a meeting required to be posted under section 551.043(a) of the Texas Open Meetings Act, at which a governmental body will discuss or adopt a budget for the governmental body, must include a taxpayer impact statement showing, for the median-valued homestead property, a comparison of the property tax bill

in dollars pertaining to the property for the current fiscal year to an estimate of the property tax bill in dollars for the same property for the upcoming fiscal year.

PRESENTATIONS

1. PROCLAMATION FOR SAFETY WEEK 2026. - Human Resources Specialist Jessica Cantu announced that it was City Safety Week for the week of June 22-26, 2026. Ms. Cantu stated that Safety Week is led by the City's Safety Committee and provided an overview of the committee's efforts to promote a culture of safety, increase employee awareness, and encourage safe work throughout the organization.

Ms. Cantu reported that this year's activities include training and educational sessions on driving safety, Narcan administration, mental wellness, heat illness prevention, hurricane preparedness, and pet emergency preparedness, as well as employee engagement activities that reinforce the importance of workplace safety. She stated that the goal of the program is to support a safe and healthy work environment for all City employees by reducing workplace injuries and associated costs.

Ms. Cantu further noted that Safety Week will include a "Turn up the Heat" employee engagement event featuring a chili cook-off and salsa competition.

Mayor Mouton proclaimed the week of June 22 - 26, 2026, as the City's Safety Week and presented a proclamation to the Safety Committee.

JOINT PUBLIC HEARING WITH PLANNING & ZONING COMMISSION AND CITY COUNCIL.

2. JOINT PUBLIC HEARING AT THE REQUEST OF RYAN TAYLOR TO REZONE 5151, 5301, AND 5401 RED BLUFF ROAD LOT 1 BLK 1 DEER PARK RV FROM HIGHWAY SERVICE (HS) TO M1 INDUSTRIAL PARKS. - Mayor Mouton opened the public hearing on behalf of City Council at 7:37 p.m., and Secretary Craft opened the public hearing on behalf of the Planning and Zoning Commission at 7:39 p.m.

Mayor Mouton directed City Secretary Angela Smith to read the Notice of Public Hearing into the record.

Mayor Mouton called for those desiring to speak in favor of this request.

Ryan Taylor, the applicant spoke in favor of the rezone request for 5151, 5301, and 5401 Red Bluff Road Lot 1 Blk 1 Deer Park RV from Highway Service (HS) to M1 Industrial Parks. Mr. Taylor provided an overview of the request and described the subject property as approximately

22.9 acres consisting of three addresses under a single parcel. Mr. Taylor stated that the property is located in the southwest corner of the City of Deer Park, adjacent to the City of Pasadena, and has remained underdeveloped.

Mr. Taylor stated the proposed rezoning from Highway Services (HS) to Industrial Park (M-1) would allow for office warehouse development with outdoor storage. He noted that the property is located outside the floodplain, utility service is available, and driveway permits have been obtained through the City of Pasadena.

Mr. Taylor believes the proposed rezoning represents the highest and best use of the property. He noted that a letter of support had been received from the Deer Park Chamber of Commerce and that the proposed development could contribute to economic development, job growth, and additional tax revenue for the City.

Mayor Mouton called for those desiring to speak against this request. No one spoke.

Mayor Mouton closed the public hearing on behalf of City Council at 7:40 p.m., and Secretary Craft closed the public hearing on behalf of the Planning and Zoning Commission at 7:40 p.m.

5. CONSIDERATION OF AND ACTION ON AWARDING THE CONTRACT FOR TALLOW MITIGATION SERVICES FOR THE CITY OF DEER PARK TO HGS, LLC DBA RES ENVIRONMENTAL OPERATING COMPANY, LLC. - Motion was made by Councilwoman Garrison and seconded by Councilman Haight to award the contract for tallow mitigation services for the City of Deer Park to HGS, LLC dba RES Environmental Operating Company, LLC., for an amount not to exceed \$99,724.00.

CONSIDERATION OF AND ACTION ON APPROVING AMENDMENT NO. 1, WITH COBB FENDLEY & ASSOCIATES FOR THE G105-04-01 DRAINAGE OUTFALL IMPROVEMENT PROJECT TO PROVIDE CONSTRUCTION PHASE SERVICES. - Motion was made by Councilman League and seconded by Councilwoman Ford to approve Amendment No. 1 to existing agreement with Cobb Fendley to provide Construction Phase Services for an additional \$61,590.00 on the G105-04-01 Drainage Outfall Improvement Project.

8. CONSIDERATION OF AND ACTION ON ACCEPTANCE OF THE COMPLETION OF AND RELEASE OF RETAINAGE FOR THE SPENCERVIEW BRIDGE PROJECT BY LUCAS CONSTRUCTION. - Motion was made by Councilman Ginn and seconded by Councilman Ripley to accept the project completion of and release retainage in the amount of \$20,006.15 for the Spencerview Bridge Project completed by Lucas Construction.

CONSIDERATION OF AND ACTION ON THE ADOPTION OF A RESOLUTION BY CITY COUNCIL OF THE CITY OF DEER PARK, TEXAS, AUTHORIZING TO ACCEPT A FEMA BUILDING RESILIENT INFRASTRUCTURE AND COMMUNITIES (BRIC) GRANT AWARD AND EXECUTE THE ASSOCIATED PROJECT AGREEMENT THROUGH THE TEXAS DIVISION OF EMERGENCY MANAGEMENT (TDEM) FOR THE INSTALLATION OF PERMANENT BACKUP GENERATORS AT 13 WASTEWATER LIFT STATIONS. - After a proposed resolution was read by caption, motion was made by Councilman Haight and a second by Councilman League to adopt Resolution No. 2026-06 captioned as follows:

CONSIDERATION OF AND ACTION ON THE RESULTS OF THE JOINT PUBLIC HEARING WITH CITY COUNCIL AND PLANNING & ZONING COMMISSION ON THE REQUEST FROM RYAN TAYLOR, AS REPRESENTATIVE OF PARKED LLC, ON A PROPOSED AMENDMENT TO ORDINANCE NO. 3886, TO REZONE 5151,5301, AND 5401 RED BLUFF ROAD, LOT 1, BLK 1, DEER PARK RV HIGHWAY SERVICE (HS) TO INDUSTRIAL PARK (M1). - After a proposed ordinance was read by caption, motion was made by Councilwoman Garrison and a second by Councilman Haight to adopt Ordinance No. 4705 captioned as follows:

CONSIDERATION OF AND ACTION ON ENTERING INTO AN AGREEMENT WITH STUDIO RED FOR DESIGN SERVICES FOR RENOVATIONS TO THE EXISTING COURT/THEATRE BUILDING. - Motion was made by Councilman Ginn seconded by Councilman League to approve entering into an agreement with Studio Red for design services for renovations to the existing Court/Theatre Building for a proposed price of \$197,340.

Motion carried 7 to 0.

16. CONSIDERATION OF AND ACTION ON PURCHASING THE SERVICES OF BRANCH CONSTRUCTION, VIA TIPS CONTRACT NUMBER 23010401, FOR THE CONCRETE DITCH IMPROVEMENT BETWEEN E SAN AUGUSTINE AND EAST P STREET (DITCH ID #B112-04-00). – Motion was made by Councilwoman Ford and seconded by Councilman League to approve the purchase of services of Branch Construction, via TIPS contract number 23010401, for the Concrete Ditch improvement between E San Augustine and East P Street (Ditch ID #B112-04-00) for the proposed amount of \$198,982.00.

Motion carried 7 to 0.

17. CONSIDERATION OF AND ACTION ON PURCHASING THE SERVICES OF BRANCH CONSTRUCTION GROUP, VIA TIPS CONTRACT NO. 23010401, FOR THE EAST X STREET PAVEMENT IMPROVEMENTS BETWEEN LUELLA AVENUE AND KARANKAWA COURT. - Motion was made by Councilman League and seconded by Councilman Ripley to approve the purchase of services from Branch Construction Group, via TIPS Contract No. 23010401, for the East X Street pavement improvements between Luella Avenue and Karankawa Court.

Motion carried 7 to 0.
